- The VA will only pay for courses that apply to a student's certificate or degree program. The Veterans Administration will have the cost of an Incomplete (I) class returned to the VA if no grade is assigned after a year.
- The URI Certifying Official cannot certify students for courses that are not part of their program. This means the Tuition and Fees will not be paid for that course (under CH 33) AND the student's monthly stipend will be reduced (under all VA Education benefits).
- Certificate of Eligibility (COE) – URI requires an up-to-date COE be submitted to the VA Office of Enrollment Services. COE is the letter you receive from the VA indicating your entitlement to VA benefits.
