**General Education Requirements:** Students must complete 40 credits of general education courses. Each of the twelve outcomes (A1-D1) must be met by at least 3 credits. No more than 12 general education credits can have the same course code unless it is HPR. A single course may meet more than one outcome, but cannot be double counted towards the 40 credit total. General education courses may also be used to meet requirements of the major or minor.

**Global Cultural Experience:** There are multiple ways to satisfy the global cultural experience requirement. Study abroad and a second Gen Ed C2 are two of them. Many business students choose to complete their C2 gen eds by studying a language. See catalog for further details.

### Business Requirements:

1. Students must meet the requirements of an overall GPA of 2.5 and a 2.70 or higher average in BAI111, ACC201, ACC202, BAI210, ECN201, and ECN202 to be eligible to transfer into the degree granting college.
2. Students must earn a C or better in ACC301. Students can only repeat ACC301 one time.
3. MGT 445 Prerequisites: ACC 202, FIN220 or 220H, MGT341 or 341H, SCA255, MKT265 or 265H, and INE315 or INE304G.
4. Business majors can use up to 6 credits of free electives towards internships.

### Graduation Requirements:

1. A minimum of 120 credits with an overall GPA of 2.0. An overall GPA of 2.0 (including all attempts) is mandatory for the eight 300 and 400 level courses required for the Accounting major
2. Half of the credits (4 courses) in the major must be completed at URI. All courses for the major must be taken at an AACSB accredited business school.

### Transfer Credit Requirements:

1. Students who wish to study at another college or university must obtain prior approval from the Dean's office and earn a grade of C or better for the credits to transfer. Students will receive credit on their transcripts and not a letter grade.
2. Credit transferred from a community or junior college is limited to half the credits required for the University of Rhode Island degree. For a degree in business, that limit is 60 credits. Junior and Senior courses not completed at an AACSB accredited college will be transferred as free elective credits only.

### Honors

To receive a notation on their transcripts stating they have "completed the University Honors Program," students must take 24 credits in Honors Program courses (transfer students may take 18). Honors Program credits include:

#### Honors Core (14 credits):

HPR 100-level course (meets Gen Ed requirements)(3 crs.)  
 Honors Colloquium (HPR 2XX) (4 credits)  
 HPR 401 Honors Project (min. 3 crs.) (D1)  
 HPR 403 Honors Reflections (1 credit) (pre-req. Honors reflection journal completion across 4 years)  
 One HPR/H-Section course (can meet Gen Ed.) (3 crs min.)

#### Honors Electives (10 credits):

Learning experiences (max 8 crs.); Honors Contracts (8 crs.); HPR/H-section courses; Graduate-level courses
