I. Guest Speaker: Brandon Fuller, Manager, Web Communications, Communications & Marketing | Chair, Web Policies Committee

Web Communications Manager Brandon Fuller presented on best practices for accessibility across the University's website, estimated to have 6 million visits annually. Manager Fuller also discussed the current Web Content Accessibility Guidelines 2.1, Level AA (WCAG). As a state agency, URI is required to comply with these technical standards and shared a summary of the University's compliance efforts. II. Guest Speaker: ADA Parking Space Enhancements -Ken Burke, Associate Director, Office of **Capital Projects**

Associate Director Burke provided the Task Force with an update on upcoming campus construction and other capital projects impacting parking, data collected and reviewed, and introduction of wayfinding signs directing community members to available parking. The Office of Capital Projects (OCP) has undertaken these projects in partnership with Public Safety and Transportation and Parking Services. Associate Director Burke requested the task force's feedback on the proposed striping efforts and areas of need for accessible parking. Members recommended using the updated international symbol of accessibility for parking projects.

Co-Chair Smalley asked the task force to review the proposed definition on or before May 2d. A clean copy will be provided at the next meeting for discussion and voting as the task force's deliverable for the year.

The task force reviewed a draft community announcement. Members agreed on the importance of highlighting that the task force is working on launching a website, developing communications structure, creating accessibility definitions, and planning to host an event in the fall. The task force will review a final draft at the May meeting.

Recommendations: University Events or University Resources to be Highlighted -Co-Chair Smalley Co-Chair Smalley reviewed proposed events including an information session, an informal listening session in drop-in format, and in-person meet and greet with refreshments. The task force was inclined to merge the 3 proposals. CED agreed to host and sponsor.
