I. Call to order

★ The meeting was called to order at 2:03 pm by Chair Saint-Eloi Cadely.

II. Introductions

- A. Graduate Council Role, Responsibilities, and Overview (Saint-Eloi Cadely and DeBoef)
 - Dean DeBoef discussed the role of the council, committees, and expectations. In addition, the council reviews EGRA awards in October with a meeting in November set aside to review the results as a group. Dean DeBoef provided a couple of examples of upcoming topics and welcomed the council to suggest agenda topics as well.

V. Announcements

- A. Enrollment Update (Kulesh)
 - Director Kulesh presented enrollment data reflected as of last Thursday. The numbers reflect unique students with a 20% increase in online calendar programs, 451 students in Fall 2024 compared to 375 last year. The traditional calendar programs have an increase of 6%, 1,792 students in Fall 2024 compared to 1,689 last year. The numbers may change due to deferments.
- B. Professional Development (Mitnick)
 - 1. Associate Dean Mouw reminded the council to review the Graduate School Newsletter as it contains upcoming Professional Development programs as well as resources for

students. She asked the council to encourage their students to take one of the badge programs the Graduate School Offers.

- 2. Diversity and Inclusion Badge Program (DIBP, Mouw)
 - a) Associate Dean Mouw announced the DIBP fall programs are available and that students would need to take 5 workshops to earn a badge.
- 3. Equitable and Inclusive Teaching and Pedagogy Badge Program (EITP, Mitnick)
 - a) Associate Dean Mouw discussed that the EITP is designed for students interested in becoming future educators with the same concept of taking 5 workshops to earn a badge. Dean DeBoef will be teaching one of the workshops.

 - a) Associate Dean Mouw explained that the Graduate School has decided to hold a separate meeting for new program directors prior to the annual program directors meeting. - B. EGRA Awards (Mouw)
 - 1. Council Responsibilities
 - a) Associate Dean Mouw announced that the EGRA competition will open soon. The proposals are formed into groups; humanities and social sciences versus natural sciences and physical sciences. The council is tasked with reviewing the proposals assigned, adding comments, and ranking the proposals. The rankings will take place during the last Graduate Council meeting where the groups will discuss the scores and provide a ranking. Associate Dean Mouw reminded the council that their commitment to the reviews is important and thanked the council for their dedicated time. Jessica Coyle requested that the council notify the Graduate

School as soon as possible if an emergency prevents them from reviewing the proposals, so that the proposals can be delegated.

- C. Mentoring Program Initiative (Mouw)
 - Associate Dean Mouw announced that the Graduate School is launching a mentoring program. There will be programming focused on faculty, graduate students, and facilitated combined sections bringing in both communities together around developing and facilitating mentoring plans. Workshops are launching this Fall. In the Spring, there will be something similar for individual development plans. In the near future, the Graduate School will be launching a graduate mentoring committee.
