## [1] Call to order:

## [2] Update on Community Services and Event Organizing Committee:

- Until Asta joined the meeting Karolina gave an update on the upcoming event "Paint the town" glass painting event scheduled on Feb 10<sup>th</sup>.
- Helani gave the headcount of the people who has registered for the event.
- Since the expenses for the event are expensive Karolina suggested Rock climbing (a free-of-charge event) for the next month to balance finances for Spring semester events.
- Karolina informed about the upcoming Graduate Student conference that must be planned.
- Denis suggested inviting a keynote speaker from the Cybersecurity & Forensics department.

### [3] Report on the GSA's financial status:

- Obed reported on the GSA's financial status for January 2024 to the executive board and general body.
- Motion to record was placed by Karolina. Denis and Abdul seconded.
- Obed, the regalia, conference, and other reimbursements as well as officers and senators remunerations need revisions.
- Asta requested Obed to check on the accounts to present for the next meeting in order to plan strategically on the different compensation and reimbursement adjustments.
- Cherrie suggested sharing a document on accounts at the next general assembly meeting.
- Obed mentioned that the budget available for Spring 2024 is a carry-on from last semester (Fall 2023).

## [4] Announce the newly selected officers for the GSA e-board and senate body:

- Asta welcomed the new GSA senator. Florence Fields Biological Sciences.
- Asta announced the newly elected e-board members by unanimous votes.

## [5] New Business:

  - Gaps of bylaws and revising the wording in bylaws and constitutions that are open to interpretation and need clarification. Mainly "student fee", "full service of role" etc. Directed bylaws committee to initiate the work and draft the amendments for discussion by the senate.
  - ♦ Increasing reimbursements for Fall 2024.
  - ♦ Directed the elections and nomination committee to start working on the upcoming election for GSA e-board in April 2024.
  - Spring 2024 combined graduation of graduates and undergraduates. Thus, in graduate school working on a reception & award ceremony, GSA might be requested to assist in sponsoring the food just like the Luncheon for new students.
- II. Decision on funding the first event of a new student group.
  Asta informed that the African Student Connect requested for USD 300 to screen the cup of the championship.
  - ♦ Motion placed Karolina, Seconded Denis and Abdul, Objections 1
  - Motion passed after majority votes.
- III. The attendees in the meeting discussed on student groups and funding allocations. Discussion points are,
  - ♦ Should request funds with a budget 2 weeks before the event.
  - GSA should be informed in creating a student group.
  - Need to have a responsible and accountable approach to financial spending toward student groups and to add more scrutiny.
  - Asta explained the lack of policy grounds for such scrutiny based on the current GSA constitutions and bylaws. Reviewing such policies will be part of the new amendments to come. Having better student organization registration systems.
