DEFINITIONS

This report contains non-duplicated headcounts and enrolled credit totals for all students enrolled at the University of Rhode Island as of the date noted. Terms in the body of the report are defined as follows:

1. UNDERGRADUATE STUDENTS

- a) **BACHELOR'S DEGREE - full-time** -- Matriculated undergraduate students enrolled for 12 or more credits.
- b) **BACHELOR'S DEGREE - part-time** -- Matriculated undergraduate students enrolled for fewer than 12 credits.
- c) **NON-DEGREE - credit** -- Non Matriculated students who have not earned a baccalaureate degree.

2. GRADUATE STUDENTS

- a) **MASTER'S DEGREE - full-time** -- Matriculated graduate students in Master's degree programs enrolled for 9 or more credits (or with assistantships and enrolled for 6 or more credits).
- b) **MASTER'S DEGREE - part-time** -- Matriculated graduate students in Master's degree programs enrolled for fewer than 9 credits and without assistantships.
- c) **DOCTOR'S DEGREE - full-time** -- Matriculated graduate students in Doctor's degree candidates programs enrolled for 9 or more credits (or with assistantships and enrolled for 6 or more credits).
- d) **DOCTOR'S DEGREE - part-time** -- Matriculated graduate students in Doctor's degree programs enrolled for fewer than 9 credits and without assistantships.
- e) **DOCTOR'S DEGREE (PP) - full-time** -- Matriculated graduate students in Doctor's degree professional practice programs (Pharmacy PMD) enrolled for 12 or more credits. Formerly designated as First Professional.
- f) **DOCTOR'S DEGREE (PP) - part-time** -- Matriculated graduate students in Doctor's degree professional practice programs (Pharmacy PMD) enrolled for fewer than 12 credits. Formerly designated as First Professional.
- g) **DEGREE - continuous registration** -- Matriculated graduate degree candidates who have completed all required course work and research credits but who have not fulfilled final requirements for graduation.
- h) **CERTIFICATE - full-time** -- Matriculated post-baccalaureate students seeking certification enrolled for 9 or more credits (or with assistantships and enrolled for 6 or more credits).
- i) **CERTIFICATE - part-time** -- Matriculated post-baccalaureate students seeking certification enrolled for fewer than 9 credits and without assistantships.
- j) **NON-DEGREE - full-time** -- Non-matriculated post-baccalaureate students enrolled for 9 or more credits.
- k) **NON-DEGREE - part-time** -- Non-matriculated post-baccalaureate students enrolled for fewer than 9 credits.

3. OTHER STUDENTS

- a) **BACHELOR'S DEGREE - Off-Campus Study** - Matriculated students who are temporarily studying away from the University.

- b) **NON-DEGREE - Non-Credit** -- Non Matriculated Students enrolled in courses that award no college credits.

4. ENTRY STATUS

- a) **CONTINUING** -- Students who were enrolled in a previous semester.
- b) **NEW** -- New degree-seeking students are freshmen enrolled for the first time and who entered the University this semester with fewer than 24 advanced standing credits. New non-degree students are non-matriculated students who enrolled at the University for the first time this semester.
- c) **TRANSFER** -- Undergraduate students who entered the University in this semester with 24 or more advanced standing credits.

5. RESIDENCY STATUS

- a) **RESIDENT** -- Students whose homes are in Rhode Island and are assessed tuition at the resident rate.
- b) **NON-RESIDENT** -- Students whose homes are not in Rhode Island and who are assessed tuition at the non-resident rate.
- c) **FOREIGN** -- Students who report home residency in another country regardless of citizenship or race/ethnicity status. Tuition is assessed at the non-resident rate.
- c) **REGIONAL** -- Students from other New England states enrolled in selected academic programs. Tuition is assessed at the resident rate plus a 75% surcharge.

6. CLASS YEAR

- a) **FRESHMEN** -- Students with up to 30 earned credits at start of semester.
- b) **SOPHOMORE** -- Students with 31 to 60 earned credits at start of semester.
- c) **JUNIOR** -- Students with 61 to 90 earned credits at start of semester.
- d) **SENIOR +** -- Students over 90 earned credits at start of semester.

7. **RACE/ETHNICITY** -- Self-reported by students according to federally defined categories new in 2009 (Non-Resident Alien, Hispanic, Asian, Native Hawaiian or Pacific Islander, Black, Native American, White, Two or More Races, and Not Reported). By definition, Non-Resident Alien status is determined first, then Hispanic ethnicity, and then if neither is applicable, race is determined.
