Course Description

This course combines essential life and professional skills by teaching effective means of communication and conflict resolution.

In this course, students will be introduced to mediation principles, phases of mediation, mediator's role, impasse, and standards of the profession. The theoretical practice of mediation will be woven into the practical application via role plays.

A certificate of completion will be issued to participants who successfully complete a minimum of 30 hours of mediation training. This certificate provides confidentiality in the mediation process under R.I.G.L. Sec. 9-19-44.

Course Objectives

- 1. Gain factual knowledge about the principles, phases, and standards of the profession of facilitative
- 2. Demonstrate the ability to conduct a complete mock mediation, employing the skills, strategies, and processes learned
- 3. Appropriately use inquiry techniques to explore and analyze the issues of the conflict in order to summarize parties' positions, related feelings, and underlying interests
- 4. Understand negotiation theory, exploring best and worst case alternatives to reaching agreement, and the role of the third-party neutral in assisting in a negotiation
- 5. Understand and apply the essential elements of a lasting agreement

Readings

To be assigned. No textbook is required; however, links to specific articles and PowerPoints will be provided.

Evaluation and Grades

Mediating In-Class Role Plays and Debriefing (50%)

This includes all role-play mediations with the exception of the final mediation. Students will be graded on competency at the level at which you are trained (i.e. the expectations of your competency will increase with each mediation). The content of each role-play for mediation will be given out immediately prior to the role-play.

Class Participation/Attendance (20%)

Attend all classes and be punctual. This is an experiential class where your presence and participation is mandatory. Additionally, as a J-Term class, there are only five (5) classes in total. If you have to miss even one class due to work or another commitment, we strongly urge you to drop this class. If you must be absent from class for some legitimate reason (university approved absence), you are required to notify the instructors in advance and make alternate arrangements (in consultation with the instructor) for any activities for which you are responsible, if it is permissible by the instructors. Tardiness and leaving early will result in significant deductions from your participation/attendance grade. To earn the certificate of completion as a mediator, a minimum of 30 hours of training is required.

Class participation will be evaluated on thoughtfulness of comments, questions, and responses. Students are expected to actively engage in class discussion. Text messaging or the use of smartphones at any point while class is in session will result in point deductions at the discretion of the professor.

Homework (20%)

Homework will be assessed according to thoughtfulness of answers and professionalism of the document.

Final Mediation (10%)

For the final mediation students will be expected to complete a full mock mediation, from introductions to agreement writing.
