Policy Statement

Hunting is disallowed on all University Property unless provided by Exceptions as noted below. This policy does not apply to the capture of aquatic fish, shellfish, insects, amphibians, or reptiles when such capture is undertaken as a component of a bona fide research or teaching endeavor undertaken through the auspices of the University.

Open spaces that might reasonably be construed as available for hunting will be posted, to the extent practical, with "No Hunting" signs by the University. Facilities Operations will be responsible for any initial posting and all maintenance of such postings on all University Property including the Kingston, W. Alton Jones, and Narragansett Bay campuses.

Exceptions

The University is responsible for maintaining the integrity of its property and thus there is an exception for the trapping or destruction of nuisance animals that present a clear menace to property, livestock, or humans by the University or its contractors. Regulations regarding trapping of furbearing nuisance animals can be found at RIGL § 20-16 (Furbearing Animals). The removal of nuisance animals must be coordinated through Facilities Operations, including, at minimum, notification of the removal activity when undertaken by a third party. Facilities Operations may, at its discretion, deny the third-party removal should it determine to complete the removal activity itself.

Exceptions for research activities other than those outlined above are allowed when permitted through IACUC review. For research or teaching activities that fall under both IACUC review and the terms of this policy, IACUC shall provide notification of the Hunting activity to the Vice President for Administration and Finance as a component of the IACUC approval.
