Students paid hourly (not GRAs) do not qualify for fringe benefits during the academic year; 7.65% FICA - summer.

All But Dissertation (ABD) GRAs should be budgeted for stipends, fringe, fees (100%), and a percentage in-state, regional, or out-state tuition of the annual amount. Please see the Graduate Assistantship Cheat Sheet

*For 2025–2026, students will be charged 35% of standard fees (Health Services, Registration, Student Services, and Technology Fee), increasing to 40% in 2026–2027 and 50% in 2027–2028

Undergraduate students typically do not get annual increases.
