SERVICE & TRAINING

The December RICA meeting, held at Richard's Pub and restaurant, was well attended by seventy members and guests; everyone enjoyed the food and the raffle and auction. Special thanks to Wakefield Liquors, Len Andrews, and Walter Williams for raffle contributions, and to Barbara Fraiser for assisting with the dinner attendee sign-ins. The President, Vice President, Secretary and Treasurer were present. A motion was made and passed to donate \$250.00 each to: the Lawing Family Fund (in memory of Michael Lawing ('07) Richmond PD), Amos House, the RI Food Bank, the Child and Family RI, and the Jonnycake Center of Peace Dale (in memory of Helen Palmer). The RICA/RISCL challenge coins were given to members who had not yet received one. Nominations for officers: President: Tino Natale ('14); Vice President: Barbara Frasier ('03); Treasurer: Dennis Hilliard ('77). No other nominations were offered, so each nominee was voted into their respective positions for the following year. For Secretary nominees were: Jane Northup ('11) and Karen Haar ('24). By a hand count, Karen Haar received most votes and was installed as Secretary for the 2025 year. R I C A Directors are: John J. Dube ('91), Michael P. Clancy ('96) and James Clift ('02).

Progress Report for 2024 January – December: There was a 21.7% decrease (422 vs. 539) in the number of new cases and a 25.2% decrease (2,226 vs. 2,976) in the number of exhibits submitted to the Laboratory from January 1 to December 30, 2024, compared to the same period in 2023. The RI State Crime Laboratory Commission met on October 23, 2024 and on January 23, 2025, at the Attorney General's Office in Cranston. Chief Thomas Oates, Woonsocket PD, who serves on the Commission, was installed as President of the RI Police Chiefs Association at the Association's meeting on January 12, 2025.

Laboratory staff made twenty-four (24) presentations during this period. Laboratory staff members attended more than forty-six training, on-line and in-person. There were twenty-two tours of the State Crime Laboratory. There were five media or student interviews provided. The Laboratory hosted an Expert Witness Testimony Workshop, and a monthly meeting of the RI Detectives Association. The Laboratory provided two internships between June and August 2024 to a student from Roger Williams University and a student from Penn State University.

Alec Wyers continues his training as a Firearm and Toolmark Examiner. He is attending the ATF's National Firearms Examiner Academy in Maryland until May and expects to complete the training in September. The process to complete cases using contracted Firearms examiners continues with Matt Parlow and Chris Painton each working at the Laboratory 20 to 30 hours a week. The search for two Firearms and Tool Mark examiners continues with only partial success. There have been only two potential qualified applicants and only one remains a viable applicant. Hopefully, we will be able to fill one of the positions by April. The positions remain open until filled.

The 2024-2025 BCI course began on September 6, 2024, with 35 attendees. They will complete their training on April 4^{th} . The 2025-26 class is already filled.

The Forensic Science Partnership (FSP) is in its 26th year of seminar programs relevant to criminal investigations and forensic science. Many of the previous seminars were recorded and are available for viewing through the FSP website. The schedule for the Spring 2025 seminars is posted at the website. • FUNDING

The FY2025 budget is in progress, and we have submitted the FY2026 request. If you meet with your State Representatives and/or Senators, remind them of the work of the State Crime Laboratory and ask them to support our FY2026 budget request. We have applied for two Byrne/JAG Grants to assist with the contracting costs of firearm examiners and to replace our Laboratory Information Management System (LIMS) program.

As always, if you have an opportunity to speak with our Federal Senators and Representatives or their staff members, remind them of the importance of federal grant programs. We rely on Byrne/JAG and Coverdell Grant awards to maintain our accreditation and provide equipment, supplies, and training opportunities not covered in the budget.
