SS-25/26-11 – BILL AMENDING THE STUDENT SENATE BYLAWS TO REFLECT NEW STUDENT ORGANIZATION RECOGNITION POLICY

<u>Whereas</u>, the Student Organizations Committee is responsible for recognizing and supporting student organizations on campus; and

<u>Whereas</u>, student organizations currently may submit recognition applications and model constitutions at any point during the academic calendar; and

<u>Whereas</u>, the lack of submission structure creates administrative challenges and restricts organizations from having adequate time to transition into Senate recognition and utilize funds; and

<u>Whereas</u>, establishing a six-week deadline ensures sufficient time for Senate review, while providing organizations with time to apply; and

Whereas, organizations that miss the deadline will retain the ability to apply and be reviewed the following semester; and

<u>Whereas</u>, following the deadline, the Student Organizations Committee will utilize the remaining weeks of the semester to advise, support, and run programs to assist the existing club roster

Resolved, be it enacted by the University of Rhode Island Student Senate that:

Section 1. Definition

- 1.1 The Student Senate may recognize student organizations whose missions and actions are unique and serve to better the University community.
- 1.2 Recognition may be granted by a majority vote of the Assembly.

Section 2. Eligibility for Recognition

- 2.1 No student organization may be recognized which does not have at least ten (10) members, of whom a majority are undergraduate students.
- 2.2 The Student Organizations Committee will maintain a Model Constitution and no student organization may be recognized unless it has approved a constitution containing all provisions of the Model Constitution or reasonable substitutes therefor.
- 2.3 No student organization may be recognized which cannot demonstrate that it does not present an undue risk to the health, safety, and welfare of its membership or the student body.
- 2.4 Student organizations must meet and follow the proper election rules for officers provided by the Student Senate. Student organizations must meet weekly or monthly.
- 2.5 The Student Organization Committee will advise the Assembly on whether or not a student organization should be recognized based solely on the provisions of the Student Senate's instruments of organization.
- 2.6 No student organization shall be recognized unless at least one (1) member of the executive board have received Bystander Awareness Training through the i-Stand Program.
- 2.7 Training sessions will be offered at the first and last Presidents Meeting of the year.
- 2.8 If members are not able to attend these trainings offered at the President's Meeting, they must set up their own training through the i-Stand office within a reasonable time as deemed appropriate by the Student Organizations Committee.
- 2.9 Following the elections for the executive board in the Spring, clubs will have until the first President's meeting of the following semester to train their executives.
- 2.10 The Student Senate functions as though it were inherently recognized.

Section 3. Senate Recognition Period

- All student organizations seeking Senate recognition must submit their recognition application and model constitution within the first six (6) weeks of the academic semester; deadline to be advertised and disseminated by the Student Organizations Committee and the Student Senate Director of Communications.
- 3.2 Applications submitted after the six week deadline shall be processed the following semester with no delay or late penalty.
- 3.3 Exceptions to the deadline may be granted only in cases of administrative error or extenuating circumstances, at the discretion of the Student Organizations Committee by a two-thirds (2/3) vote.
- 3.4 Organizations that miss the deadline are encouraged to attend workshops and advising sessions hosted by the Committee during the remainder of the semester to prepare for future recognition.

Section 4. Rules for Recognized Student Organizations

- 4.1 The President of each Senate recognized organization must attend a monthly Student Organizations Meeting hosted by the Student Organizations Committee either in person or by proxy to discuss upcoming events and reflect on relevant experiences. Five (5) business days' notice will be given for these meetings.
- 4.2 Student organizations, once recognized, must reapply annually in order to be re-recognized.

4.3 If student organizations have a problem or dispute between them, the officers may reach out to the Student Organizations Committee to mediate the issue. This complaint must be made in writing or through an email

Section 5. Non-Discrimination Clause

- 5.1 No student organization shall be permitted to discriminate, limit membership, or in any way impede equal opportunity on the basis of race, color, sex, gender, sexual orientation, disability, national origin, age, marital status, political affiliation, nor religious affiliation nor any other non-merit factor unless limitation in membership is relevant and important to the mission of the organization.
- 5.2 Limitation in membership is relevant and important to the mission of the student organization if including members whose nature or viewpoint disrupts the functioning of the organization in such a way that the organization's freedom to associate is compromised.
- 5.3 The Student Organization Committee determines whether limitation in membership is relevant.

Section 6. Revocation of Recognition

6.1 The Senate may, at any time, cease to recognize any student organization which poses a clear and direct threat either to the Student Senate or the Student Body, jeopardizes the Student Senate's status as a 501(c)(3) non-profit organization, or fails to meet recognition requirements. Such an act must be done through legislation proposed by the Student Organizations Committee.

Senator D'aillo:

ACTION:

- What made you choose the six week deadline instead of the eight or nine weeks Senator D'aiello:
 - WE thought that pushing it later into the semester your pushing it past thanksgiving in finals week, past that point we want to assist them in

Chair Gonzalez:

- I have a lot of concerns about the six week period, it is hard on top of being a student, that six weeks is not a lot of time in the grand scheme of things, I don't think six weeks is a lot of time to get into the school year and classes

Senator Curri:

- Just to reiterate, what senator milner and D'aiello, if a new clubs get a package late into the semester

Chair singh:

- Think about the finances, you can get ten people in two weeks, you start a club. As student senators it is not only our duty but think about the finances and clubs that were recognized in the first few weeks. I don't see any point in voting against this, i condemn that viewpoint.

Chair Gonzalez:

- I don't think condemning my opinion is very appropriate

Senator D'aiello:

- If the club submits their paper at the end of the six week deadline, it still takes a few weeks for the SOC committee to get through it. At the end of the semester it is
- Goal of treating each club equitably and equally
- Unfair to the club that had to stretch that the full semester

Chair hudson:

- Trying to get a club organized at any time, is fine with me. Trying to get a process started at any semester. College kids are busy. If you have any club, however long the process takes it takes

Chair Milner:

- I totally get spontaneity, it is not a barrier to entry. This isn't a barrier to entry it is just a lid on things. They will be considered after october 17th just not this semester.

Chair Gonzalez:

- I definitely agree with having a deadline, but I don't like that it's six weeks, I do agree that financial packages is difficult, but I just don't agree that it should be six weeks. I think that there is something that could be done. I think maybe if you could make it in a way that we could add on something about the clubs not receiving this package after

Chair Singh:

- To be honest I don't speak for the motion or against the motion I speak for what is right, as chair Milner said he would completely support these clubs

Chair Sawyer:

- Just for clarification purposes, these clubs would have six weeks to get fully recognized, but any time after that you guys would still help them with getting recognized the semester after

Senator D'Aiello:

- Correct this is just a way to ensure that clubs are getting fair treatment and clubs that are being recognized at the beginging of the semester are not at a funding disadvantage to those that get recognized at the end of semester. We will still help out clubs that are looking to be recognized the next year or semester after however this way it is equitable.
