#### E. PUBLIC FORUM

Envision Consulting Team and Pierre St-Germain Director of Dining Services

#### **Envision Consulting Team:**

- Before we get started I just wanted to let you know that we are using an AI notetaking app that will strip your names but I wanted to let you know
- Consultant with an independent dining firm, travels all over the country for meal plans studies
- Usually hired by the university to help understand what that contract means, look through financials and meal plans and do master plans to look at what dining plans will look at 5 years from now
- Help with any dining information gathering that is need
- On uri campus: look at the student feedback for dining
- Want to hear open and honest feedback for dining
- Would like you jump in to get some feedback
- If you speaking tell her what meal plan you have
- Want to maximie our time together
- Totally open and honest
- I may jump from person to person

Senator curry: Don't have a meal plan currently but did, I kinda wish URI had more of grab and go options. I know they have some options in the corner store. Maybe having one that has fresher options, i'm here all day that's something that I would like to see. Something that is not like just sitting in a refrigerator all day. People who are gluten free can not just pick up sandwiches or grab and go options. Almost like make your options.

- More sustenance

Chair Gonzalez: I do not currently have a meal plan. Something I wanted to talk about is the ingredients being used in the dining hall and allergies. For example a friend of mine had an allergy to sesame and they did not accommodate that. I get that in terms of food sometimes you do have use food before they go bad. I get why they would think that they would have to use it up. Not having other options and maybe thinking more about allergies. Maybe like different meals in different dining halls.

Chair Gonzalez: She said this was just one specific week, in which someone had to pay out of pocket because they

Senator D'Aiello: Heard some complaints about brookside bistro hours, for specifically commuters this is a spot on their way to their cars to grab a bite. I've heard some frustrations with them closing early on fridays

Senator stover: I personally don't go to the dining halls very often but I like the dining dollars and ram account. I think it would be a good option to just have dining dollars and ram account. You can't load dining dollars, but ram a account

Speaker rinne: if you have to load money onto your ram account can you use your aid to help pay for it, but if it's the ram account could you use aid.

If you have something left for your financial aid you could put it toward your ram account but you can not put your ram account toward your tuition bill

Vice President hailu: You know how mainfaire has fusion food, I love it but you can't use your ram account for that. It would be a good option to allow this for accessibility purposes. Cooking style: Day to day mainfaire and butterfield there is times in which they have fried food for the whole day, it is not a variety between meals. For someone who haas dietary restrictions due to religion if they go to the dining hall and request something there is sometimes the option for oily food, which is sometimes an allergy. They have an option for fresh food tuesday and thursday but no other days.

- You said you had the full meal plan for the first two years and then went down? Do you feel like you cook more or don't use your swipes

VP hailu: I live in an apartment style building, after that i can make my own accommodations, but when I get busy sometimes I can't find fresh food in the dining hall Senator McConville: For the past two weeks, I've been going to the deli and getting food but theres always the same chips do you think we could change up the chip style Senator Capraro: I just think sometimes the dining halls close a little early, i think it's 9 but if you get there at 8 everything is pretty much packed up. I think if students have an option for maybe just an hour later for students who have late classes or need that later dining hall would be able to eat

Dot Unjende: I just want to clarify an hour but with the food still available Senator Capraro: I get it we want to go home but by the time that we get there and it's 8 everything is practically packed up Chair Singh: I completely seconded Carpraros notion, because on the wednesday after this meeting, and go eat. Every time I go it is cold or packed up already. After a long long senate meeting I at least want something. I'll be honest the food isn't that good. I mean the food is decently good I'm just an internation food

- Does anyone use the rams den for late night, and is that something you use throughout the week
- Current late night options are only on wednesday

Senator Voklek: I just remember freshman year people being frustrated that butterfield isn't open on the weekends. Is that going to change

Right now we are just in the fact finding phase to see what people think on campus,
 really trying to understand why or when people are eating at certain places. We will be
 doing a survey on campus

Senator Volek: Are brownie night no longer a thing

- Nope

Senator Bremer: On the weekends I realized that at 12 or 2pm they are just serving breakfast and you can't find any lunch. There is no variety on campus.

Vp Hailu: I do not understand why we do brunch till night, that definitely needs to be changed. If there is one thing that we could emphasize is changing this one thing to make lunch accessible on the weekends. You can move on

Senator Troxell: one thing going off on the opening later and staying open later. I think it could be nice to have swipes accepted at the late night options we could potentially use this.

Senator Dickson: I'm on campus a lot and i probably eat on campus 2 or 3 times a day, the biggest issue i have is the same cycle of food at the rams den. I'm kind of sick of eating the same thing at the rams den. Maybe like a monthly cycle.

What do you want to see

Senator Dickson: haven't thought about that

Chair Gonzalez: Pizza President Reyes: No

DOT Unjende: I initially did not want to share thing but I think it would be beneficial. I personally use the rhody late nights a lot. Made me reflect on a lot of the options that we have and I feel like there is not a lot of vegetarian or vegan options. I just think that is something that we should consider.

- Typically we hear this on campus is price, either that is a good thing. Meal plan cost and

what you are paying. In the rhody corner store, or wherever. Thoughts?

President Reyes: I just find it unnecessary to purchase a meal plan that is out of my budget, Something we had talked about with pierre was having a discounted price options either biweekly, ever other day. Prices in the rams den went up significantly this year, including having to pay for protein options now. Maybe having some sales where something becomes more affordable. If we could introduce something like that I feel as if students would appreciate it.

President Reyes: More variet of breakfast options in the rams den

Speaker Rinne: bring the soft serve machine back

Senator Dionne: We do stuff for the holidays, like lunar new year

Lucas Dewitt: I would say here in this building outside of wednesdays, there is that general perception that the university shuts down after the professionals go home, but knowing that the memorial union is here on campus, but needing something to tie it in as students are studying late at night having access to their food there

Chair singh: Thank you for being here. We love you and thank you for coming

- Want to walk away and be able to give you the satisfaction you are looking for President Reyes: I had a good question and I just forgot it. Has the new franchise that is being added been announced yet
  - It has not been announced yet, they have that contract that is with legal services and I have nothing to do with it

President Reyes: Do you think students will like it

- Is it going to speak to students that are looking for more ethnically diverse options on campus? Not really. Unless someone gives me the pointed request or demand to say we want taco bell on campus (example) I would have to outline that and reach out and they would have to also be interested. WE have a very interesting place on campus where we have a bigger school but not big enough to sustain being on campus during the summer. We have to be very specific when we make requests, or anyone could apply. As we look at any changes it is important for you all to submit feedback

President reyes: so after the franchise comes what happens if the students say they don't like it

- You can't do it in a year, it would have to be at least two. The first two years is outlined in the contract as being a probation period and if students don't like it, it can be terminated.

President Reyes: Will students be able to use their ram account or dining dollars on campus

- So far just ram account because they are outside of the program, asked to hire student employees and give some benefits to the student sort of like a scholarship program.

Price point - looking at a company that had an appropriate price point

Vp hailu: Sustainability is very important to me, is there is anything that you guys are doing to avoid food waste. I know that there is an assistant sustainability advisor

- New sustainability office on campus, we have always kept our own accountability on campus
- Also with the student worker =s who are ambassadors of campus.
- Overproduction is the enemy of any food service.
- Trying to get students to try something rather than dislike it and waste it.
- When you come to the dining hall at 8pm and we are out of food that is because of people wasting food. We try to use a software to work those numbers out and use feedback, and make sure there is a

Vp Hailu: sometimes there is a case where certain food is not liked, how does this play into it

- This is tract so that we can see what is coming back and what we need to address Vp hailu: For people thaat have dietary restrictions, is there a way to work with nutritionist on campus to provide a meal that fits the diet
  - Karen Orvona: license dietitian, and beth carnan who is also a license dietitian. If any student has a concern whether it is by choice or allergy we will work with them to help get them specific suggests and plans

Vp hailu: Do they have to go to them

- They do have to email and contact them, and convey their needs

Speaker Rinne: I guess most of my data is anecdotal, but you talked about food hoarding. From what I can tell this is from the large lines where students think, they don't want to wait in line twice if they want seconds

- More so with butterfield, that is something we have looked at, we are planning in place to do a renovation of mainfaire this summer. The day that classes end mainfaire dining hall goes offline and rip apart and renovate mainfaire. Changing the options of the rhody market, adding seats, and turning the current deli into an allergen friendly station. Turning that into a cold and hot deli.

Senator Abott: I don't know if this something that you control but I can't order ahead with a flex slipes on grubhub for the brookside bistro.

- We recently changed the system, but we might not have made the correct adjustments so I'll look into that

Senator Abott: I work at butterfield and some of my coworkers have expressed that the Sobat machine is broken

- We had requested from the company that they fix that but are still looking for certain communication
- I hope that next week if anyone gets to come by, we are doing a special dinner called the food show, so you can try other options of things that we might be offering in the next year. Wednesday and thursday next week we are having a latin heritage meal

President Reyes: The tamales were good!

### <u>SS-25/26-10 – BILL ESTABLISHING THE CAMPUS DEVELOPMENT LIAISON FOR</u> THE UNIVERSITY OF RHODE ISLAND STUDENT SENATE

<u>Whereas</u>, Much of URI Kingston Campus needs renovating and many students desire this inside dorms, academic buildings, recreational spaces and outside such as parking, sidewalks, roads, etc.

Whereas, There is no liaison seat in place in the University of Rhode Island Student Senate to directly address all types of infrastructure

<u>Therefore</u>, The creation of the Campus Development Liaison position will allow Student Senate to better represent and advocate for its constituents, and so be it

<u>Resolved</u>. That the University of Rhode Island Student Senate establishes the campus development liaison whose responsibilities shall include but are not limited to:

- 1. Dealing with and advocating for improvements to indoor and outdoor campus infrastructure including but not limited to parking lots/spaces, resident and academic buildings, sidewalks, etc.
- 2. Being the primary contact for planning and real estate development and a contact for the division of administration and finance whenever it relates to campus infrastructure.

Speaker Rinne: The following bill comes from chair hudson

# SS-25/26-11 – BILL AMENDING THE STUDENT SENATE BYLAWS TO REFLECT NEW STUDENT ORGANIZATION RECOGNITION POLICY

<u>Whereas</u>, the Student Organizations Committee is responsible for recognizing and supporting student organizations on campus; and

<u>Whereas</u>, student organizations currently may submit recognition applications and model constitutions at any point during the academic calendar; and

<u>Whereas</u>, the lack of submission structure creates administrative challenges and restricts organizations from having adequate time to transition into Senate recognition and utilize funds; and

<u>Whereas</u>, establishing a six-week deadline ensures sufficient time for Senate review, while providing organizations with time to apply; and

<u>Whereas</u>, organizations that miss the deadline will retain the ability to apply and be reviewed the following semester; and

**Whereas**, following the deadline, the Student Organizations Committee will utilize the remaining weeks of the semester to advise, support, and run programs to assist the existing club roster

**Resolved**, be it enacted by the University of Rhode Island Student Senate that:

#### Section 1. Definition

- 1.1 The Student Senate may recognize student organizations whose missions and actions are unique and serve to better the University community.
- 1.2 Recognition may be granted by a majority vote of the Assembly.

#### Section 2. Eligibility for Recognition

- 2.1 No student organization may be recognized which does not have at least ten (10) members, of whom a majority are undergraduate students.
- 2.2 The Student Organizations Committee will maintain a Model Constitution and no student organization may be recognized unless it has approved a constitution containing all provisions of the Model Constitution or reasonable substitutes therefor.
- 2.3 No student organization may be recognized which cannot demonstrate that it does not present an undue risk to the health, safety, and welfare of its membership or the student body.
- 2.4 Student organizations must meet and follow the proper election rules for officers provided by the Student Senate. Student organizations must meet weekly or monthly.
- 2.5 The Student Organization Committee will advise the Assembly on whether or not a student organization should be recognized based solely on the provisions of the Student Senate's instruments of organization.
- 2.6 No student organization shall be recognized unless at least one (1) member of the executive board have received Bystander Awareness Training through the i-Stand Program.
- 2.7 Training sessions will be offered at the first and last Presidents Meeting of the year.
- 2.8 If members are not able to attend these trainings offered at the President's Meeting, they must set up their own training through the i-Stand office within a reasonable time as deemed appropriate by the Student Organizations Committee.
- 2.9 Following the elections for the executive board in the Spring, clubs will have until the first President's meeting of the following semester to train their executives.
- 2.10 The Student Senate functions as though it were inherently recognized.

#### **Section 3. Senate Recognition Period**

- 3.1 All student organizations seeking Senate recognition must submit their recognition application and model constitution within the first six (6) weeks of the academic semester; deadline to be advertised and disseminated by the Student Organizations Committee and the Student Senate Director of Communications.
- 3.2 Applications submitted after the six week deadline shall be processed the following semester with no delay or late penalty.
- 3.3 Exceptions to the deadline may be granted only in cases of administrative error or extenuating circumstances, at the discretion of the Student Organizations Committee by a two-thirds (2/3) vote.
- 3.4 Organizations that miss the deadline are encouraged to attend workshops and advising sessions hosted by the Committee during the remainder of the semester to prepare for future recognition.

#### **Section 4.** Rules for Recognized Student Organizations

- 4.1 The President of each Senate recognized organization must attend a monthly Student Organizations Meeting hosted by the Student Organizations Committee either in person or by proxy to discuss upcoming events and reflect on relevant experiences. Five (5) business days' notice will be given for these meetings.
- 4.2 Student organizations, once recognized, must reapply annually in order to be re-recognized.

4.3 If student organizations have a problem or dispute between them, the officers may reach out to the Student Organizations Committee to mediate the issue. This complaint must be made in writing or through an email

#### **Section 5. Non-Discrimination Clause**

- 5.1 No student organization shall be permitted to discriminate, limit membership, or in any way impede equal opportunity on the basis of race, color, sex, gender, sexual orientation, disability, national origin, age, marital status, political affiliation, nor religious affiliation nor any other non-merit factor unless limitation in membership is relevant and important to the mission of the organization.
- 5.2 Limitation in membership is relevant and important to the mission of the student organization if including members whose nature or viewpoint disrupts the functioning of the organization in such a way that the organization's freedom to associate is compromised.
- 5.3 The Student Organization Committee determines whether limitation in membership is relevant.

#### **Section 6.** Revocation of Recognition

6.1 The Senate may, at any time, cease to recognize any student organization which poses a clear and direct threat either to the Student Senate or the Student Body, jeopardizes the Student Senate's status as a 501(c)(3) non-profit organization, or fails to meet recognition requirements. Such an act must be done through legislation proposed by the Student Organizations Committee.
