# **E. PUBLIC FORUM**

President Parlange, Vice-President Benson, and Vice-President of the Division of Student Affairs ~ Update on Board of Trustees Regulations

- Regulations for URI board of trustees
- Actions that have been taken since our last meeting:
  - We heard you that you needed more time and there were concerns about the regulations
  - 473 comments voicing the concerns on the regulations
  - 310 comments were from students
  - Wanted to make sure that these documents were reflective of the values of URI
- Summarization of redlines:
  - In no way trying to limit the expression of speech on the campus

- What we heard as part of the feedback is making sure that these regulations are neutral for faculty, staff, and visitors
- There is a space allocation policy that we make sure that the spaces are allocated to students first before anyone else
- Sounds: can not impede the business of the campus, amplified sounds is okay as long as it does not interfere with the university
- Bicycles, skateboard, and similar conveyance: wanted to make sure that there was an ability for accessibility still
- Department of Public Safety is primarily authorized to implement this policy in a way that is productive, only emergency measures are taken when there an actual need for the emergency services
- VP Feroz: When I was first reading this document one of the first things that I thought of was when I'm on the quad and am seeing students with hammocks, would that be considered a temporary structure?
  - Intent is not to limit the community on campus, would not be in any way a violation of the regulations
- Senator Small: I noticed that you completely removed section g, but then in section I; in addition unauthorized banners, posters that are not authorized are not allowed. It seems as if it was removed and added back later
  - Appreciate your comment on that, I believe they settled this as it would only be not allowed if it was destructing to the property on the URI campus.
  - Senator Gonzalez: what I'm trying to understand, is you would want us to stay away from expensive property
    - The destruction in my experiences is when the tap or way it is hung is taking paint off that would be considered destructive, but not if it doesn't.
  - VP Feroz: In the number 6 in enforcement and violation it points to the student handbook and the graduate student handbook, so bias claims go through the same process as it would in the student handbook. Would this be the same appeals process?
    - It would be the same as applicable in the student handbook, and may go through different offices
  - VP feroz: does this apply to non-uri affiliated people as well
    - Yes
