- C. APPROVAL OF THE AGENDA The agenda was approved by unanimous consent.
- **D. READING AND APPROVAL OF THE MINUTES** The minutes from the meeting of March 10, 2021 were approved by unanimous consent.

SS-20/21-27 — Bill Calling for Changes to the University of Rhode Island Student Senate Bylaws

<u>Whereas</u>, the Instruments Committee in its final act has found it necessary to amend the University of Rhode Island Student Senate Bylaws as follows in order to improve the Senate's efficiency, now therefore be it,

Resolved, that the final sentence of Article 1, Section 3, Part 3 of the URI Student Senate Bylaws be amended to read as follows "These positions are for reporting and discussion purposes only, and do not come with any additional powers or privileges other than speaking privileges",

and be it further,

Resolved, that a new line designated line 6.10 be added to Article 2, Section 4, Part 6 of the URI Student Senate Bylaws, which states that "Any member of the Assembly who is not on an approved leave of absence and who accrues more than 5 unexcused absences, or who is absent for more than 50% of scheduled meetings in any given semester but has not accrued more than three unexcused absences, shall be automatically removed from office. A member may appeal their ejection from the General Assembly to the Speaker of the Assembly, who will place the appeal on the agenda of the next meeting of the Assembly. A member may only be reinstated after being removed from office due to absence by a 3/4th majority vote of the Assembly,

and be it further.

Resolved, that the word "elects" Article 3, Section 1, Part 1, line 1.04 of the URI Student Senate Bylaws, be replaced with the word "confirms", and be it further,

Resolved, that the phrase, "unless objected upon by the Cabinet" be struck from Article 3, Section 1 Part 1, line 1.07 of the URI Student Senate Bylaws, and be it further,

Resolved, that line 1.15 be struck from Article 1, Part 1, Section 2, of the URI Student Senate Bylaws, and be it further,

Resolved, that line 5.01 be struck from Article 4, Section 5 of the URI Student Senate Bylaws, and be it further,

Resolved, that lines 1.04. and 1.05 be struck from Article 5, Section 1 of the URI Student Senate Bylaws, and be it further,

Resolved, that line 1.03 of Article 5, Section 1 of the URI Student Senate bylaws be amended to read as follows "Designated Authority: Member of the Student Senate designated by the Head Jurist to represent the Court."

and be it further,

Resolved, that lines 3.02, 3.03, and 3.04 be struck from Article 5, Section 3 of the URI Student Senate Bylaws, and be it further,

Resolved, that Article 5, Section 4, line 4.01 of the URI Student Senate Bylaws be amended to read as follows "The hearing will be closed to all but the members of the Assembly, the Head Jurist, and the Respondent", and be it further,

Resolved, that the phrase "Designated Authority" be replaced with "Head Jurist" in lines 4.02 and 4.03 of Article 5, Section 4 of the URI Student Senate Bylaws, and be it further,

Resolved, that line 4.04 of Article 5 Section 4 of the URI Student Senate Bylaws be amended to read as follows "The Designated Authority will read the report, to which the respondent or their designee will be allowed to respond." and be it further

Resolved, that line 4.05 of Article 5 Section 4 of the URI Student Senate Bylaws be amended to read as follows, "The Designated Authority and the Respondent or their advocate, will both be allowed to introduce witnesses and evidence as they see fit, and cross-examination and rebuttal will be allowed for each at the discretion of the Head Jurist unless and objection is made by a member of the Assembly and sustained by a 2/3rd majority vote." and be it further,

Resolved, that the phrases "Administrator and Advocate" be replaced with "Designated Authority and Respondent or their designee" in line 4.06 of 4.07 of Article 5 Section 4 of the URI Student Senate Bylaws. And be it further,

Resolved, the word "Administrator" be replaced with "Designated Authority" in line 4.08 of Article 5 Section 4 of the URI Student Senate Bylaws, and be it further,

Resolved, the terms "Designated Authority" and "Moderator" in lines 4.09 and 4.11 of Article 5 Section 4 of the URI Student Senate Bylaws be replaced with "Head Jurist" and "Speaker" respectively, and be it further,

Resolved, that line 4.10 of Article 5 Section 4 be struck from the URI Student Senate Bylaws, and be it further,

Resolved, that Article 5, Section 5, be struck from of the URI Student Senate Bylaws.
