URI STUDENT SENATE – GENERAL ASSEMBLY MINUTES September 21, 2022

A. CALL TO ORDER - Speaker Bove called the meeting to order at 6:31pm.

B. ROLL CALL

C. APPROVAL OF THE AGENDA

Chair Gibson motioned to accept the agenda. Seconded by Senator Montoya.

E. ANNOUNCEMENTS

Speaker Bove welcomed Vice President Ellen Reynolds to the chamber and informed the senate that she has recently earned her doctorate in higher education.

F. PUBLIC FORUM .

Ellen Reynolds, Interim Vice President of Student Affairs

Vice President Reynolds reintroduced herself for newer members of the Senate. She then gave an update relating

to the Counseling Center's efforts to expand access to mental health services through a third party virtual operator. She then spoke about the ongoing search the university is conducting with Issacs and Miller to find a new permanent Vice President for Student Affairs. She then reported that the university has made housing its top priority for the upcoming year, and that they are evaluating plans for constructing a new residence hall. Finally she spoke about her plans to form a new student advisory group to personally advise her on issues relating to student affairs and explained that she intends to appoint students from different organizations across campus including senate.

Chair Chadronet expressed concerns that a new student advisory committee may subvert the Campus Affairs Committee in helping to set policy on campus.

Vice President Reynolds replied that the committee will serve an informal role and that the senate will still be consulted before official decisions are made.

Vice President Gamache asked if the Division of Student Affairs will be doing anything to address the current issues with the Dining Services budget

Vice President Reynolds replied that Dining Services has seen a larger increase in expensas than any other department at URI. She further stated that it is likely that Dining Services will need to raise fees again in the upcoming fiscal year.

Speaker Bove asked Vice President Reynolds if she would commit to attending a senate meeting with Director St-Germaine to discuss dining plans before they are finalized.

Vice President Reynolds replied that she absolutely would.

Senator Bailey asked if the new virtual counseling services are administered by URI.

Vice President Reynolds said no, but that the service is run by licensed mental health counselors employed by a third party company.

President Kiernan thanked Vice President Reynolds for her time and expressed that she is looking forward to their next meeting.

Vice President Reynolds reminded senators to watch President Parlange's inauguration tomorrow.

Dr. Stiles stated that the ceremony will be livestreamed for anyone not attending in person.

G. REPORTS OF STANDING COMMITTEES

- Student Organizations Committee

Chair Gibson reminded senators to sign up for the Student Organizations fair on October 6th.

- Academic Affairs Committee

Chair Summerson reminded senators who represent a college that they must meet with their College Dean at least once a month.

- External Affairs Committee

Chair Scotti reported that a judge has suspended Naragansett's three student housing ordinance.

- Cultural Affairs Committee

Chair Tyson thanked the senators who attended last week's Cultural Committee event celebrating Hispanic Heritage Month. She then reminded senators to attend her upcoming Diversity and Inclusion Town Hall with President Parlange and other university officials on October 13 at 6:30pm in the Swan Hall Auditorium.

Chair Summerson remarked that It would be great if senators could make it a priority to attend events put on by committees they do not serve on.

- Campus Affairs Committee

Chair Chadronet said that the Blue Light Walk will be held on either October 18th or 25th. He also reported that he will be meeting with Frankie Minor to discuss the safety of communal showers in the residence halls.

- President Kiernan gave an update on Fall Fest.
- Vice President Gamache reminded senators to log their office hours, and stated that she will excuse any senator who attends Fall Fest from office hours for a week.
- Director Thiel reminded senators to fill out the senator spotlight form.
- Director Eustis stated that Halloween has been voted as the best holiday, and also that he will be working with a committee of senators to plan fall fest.
- Director Njeru reported that the bill writing workshop will be postponed until after elections.

K. UNFINISHED BUSINESS SS-22/23-10 BILL CALLING FOR THE AMENDMENT OF THE UNIVERSITY OF RHODE ISLAND STUDENT SENATE BYLAWS

Whereas, Article 6, Section 2, Line 2.6 of the Student Senate Bylaws states that "No student organization shall be recognized unless three (3) members of the executive board have received Bystander Awareness Training through the i-Stand Program", and

<u>Whereas</u>, Article 6, Section 2, Line 2.7 states that "Training sessions will be offered at the first and last Student Organizations Meeting of the year", and

<u>Whereas</u>, these training sessions have not been provided at Student Organizations Meetings during recent terms and the existence of over 100 student organizations makes it logistically difficult to provide this training to at least three (3) members of each organization, and

<u>Whereas</u>, reducing the quantity of executive board members required to complete this training will enable the senate to more easily provide this training and enforce Article VI Section 2.6 of the Student Senate Bylaws, now therefore be it,

<u>Resolved</u>, that Article 6, Section 2, Line 2.6 of the Student Senate Bylaws be amended to require read as follows, "No student organization shall be recognized unless at least one (1) member of the executive board has received Bystander Awareness Training through the i-Stand Program", and be it further,

<u>Resolved</u>, that the term "Student Organizations Meeting" in Article 6. Section 2, Line 2.7 pf the Student Senate Bylaws shall be replaced with "Presidents Meeting", and be it further,

<u>Resolved</u>, that any and all instances in which the presiding officer of a special committee is referred to as the "Speaker" within the Student Senate Bylaws, shall be replaced with the term "Leader".
