### URI STUDENT SENATE – GENERAL ASSEMBLY MINUTES October 12, 2022

A. CALL TO ORDER - Speaker Bove called the meeting to order at 6:31pm.

#### **B. ROLL CALL**

#### C. APPROVAL OF THE AGENDA

#### E. ANNOUNCEMENTS

Speaker Bove announced that tomorrow is Chair Tyson's birthday.

President Kiernan announced that Fall Fest will be postponed indefinitely with more information to follow.

### F. PUBLIC FORUM

Paige Ramsdell - Assistant Dean and Director of the Office of Disability Access and Inclusion

Director Ramsdell introduced herself to the senate. She then gave a report on the work that the Office of Disability, Access, and Inclusion has been doing in recent years to serve students with disabilities. She provided an update on trends that her office has observed and gave remarks about the unprecedented increase of students seeking accommodations in recent years. She reported that for the first time in her tenure the DAI office is fully staffed. She concluded her report by sharing DAI's mission statement and the office's guiding values.

Director Hoover stated that he realizes there is a difference between seeking DAI consultations and seeking access accommodations, and asked if there will be a way to clarify the differences for students.

Director Ramsdell said that they intentionally use the term "consultation" broadly so that student don't feel discouraged from reaching out for help regardless of the type of help they are looking for. She stated that there is a discussion to be had with students about better defining the types of work the office does.

Senator Piacentini shared that she had a very poor experience with the Disability Services Office at another institution and that she was nervous about seeking services at URI. She remarked that DAI has been very helpful and stated that she is very thankful for the work that the office is doing

Speaker Bove asked what the senate can do to advocate for DAI.

Ramsdell replied that she has never felt more supported administratively than this past month, and that Vice President Sean Rodgers has been a great supporter. She stated that DAI now has the best reporting system that they have ever had and that the best way the senate can support DAI is by encouraging students to hold the community accountable.

Senator Bailey: asked if what she should do if she has a professor who is not allowing students with DAI accommodations extended time on exams because they already have a significant amount of extra time allotted to all students to complete the test.

Director Ramsdell stated that while it is important that students receive enough time on the exam.

Senator Breene asked if students who have already been onboarded but go several months without seeking accommodations need to repeat the on boarding process in order to begin receiving accommodations again.

Director Ramsdell replied that students would not need to repeat the onboarding process.

Speaker Bove stated that in his role he frequently looks for issues at the university that need to be fixed, but throughout his four years here, he has never once had an issue with DAI. He thanked Director Ramsdell for her service to all students with disabilities, and commended the DAI staff for their outstanding performance.

Director Ramsdell replied that it is a pleasure to serve.

Keith Ranaldi - Interim Director of Entrepreneurship and Innovation

Director Ranaldi introduced himself to the senate as an adjunct professor in the College of Business, and as the Interim Director of Entrepreneurship and Innovation at URI. He outlined a potential relationship between the the Office of Entrepreneurship and Innovation, the College of Business, and the Student Senate to collect data about issues facing students at URI. He spoke about an accelerated j-term class he will be teaching relating to data collection, and expressed that he is looking forward to working with the Senate.

Senator V Johnson urged students to get involved in the College of Business's XR lab.

Speaker Bove expressed his support for this proposed partnership, and he thanked Director Ranaldi for coming to address the Senate.

#### G. REPORTS OF STANDING COMMITTEES

- Student Organization Committee
  - Chair Gibson reported that her committee has several bills on the floor and urged senators to support them. She also announced that she will be graduating in December and stated that anyone interested in running to be the next SOC chair should reach out to her so that she can train them. She also reported that she believes it has become too easy for groups to qualify for, and maintain Senate recognition, and that the committee is looking at ways to address this.
- Academic Affairs Committee
  - Chair Summerson reminded senators of the importance of submitting academic complaints when professors need to be held accountable. She also asked senators to reach out to her if they are interested in helping to plan this year's Women's Summit. She stated that you do not need to be a woman to help plan the event.
- External Affairs Committee
  - Chair Scotti reported that his committee is continuing to develop plans for a community clean up that is to

be held in Narragansett in November.

#### - Cultural Affairs Committee

- Chair Tyson reminded everyone that her diversity and inclusion town hall is tomorrow. She stated that if a senator cannot go, they should still submit a question, that would be helpful. Next week the committee will be holding a donation drive for a local refugee center in collaboration with PINK. She urged senators to donate any gently used clothing they can give.

### - Campus Affairs Committee

- Chair Chadronet reminded everyone that the Blue Light Walk will be held on Tuesday, October 18, 2022, at 6:00pm. He is also working with the Union Express to address the issues of long lines to pick up mail.
