J. UNFINISHED REPORT

<u>SS-23/24-44 - BILL CALLING FOR THE ADDITION OF A "MILITARY AND</u> <u>VETERAN STUDENT LIAISON" TO THE UNIVERSITY OF RHODE ISLAND</u> <u>STUDENT SENATE BYLAWS</u>

<u>Whereas</u> the University of Rhode Island Student Senate can help support its military and veteran students, and

<u>Whereas</u> military and veteran students are important members of the University of Rhode Island's community, now therefore be it,

<u>Resolved</u>, that a "Military and Veteran Student Liaison" position will be added to the Student Senate Bylaws, and be it further,

<u>Resolved</u>, that this position will be added to in Article 2, Section 9, Part 3, Academic Affairs Committee of the University of Rhode Island Student Senate Bylaws, and be it further,

Resolved, that text shall be added below Section 9.21 in "Part 3: Academic Affairs Committee" that reads "A member of the Academic Affairs Committee shall be appointed by the respective chair to serve as the Military and Veteran Student Liaison. The Military and Veteran Student Liaison shall meet with the staff advisor of the Military and Veteran Education (MAVE) Center monthly, meet with the president of the Student Veterans Organization monthly, and maintain monthly contact with a member of the USS Rhode Island (SSBN - 740)."

<u>SS-23/24-45 • BILL CALLING FOR THE DECLARATION OF THE 2024 SPRING</u> <u>STUDENT SENATE ELECTIONS</u>

<u>Whereas</u>, it is incumbent upon the Senate to set, confirm, and declare official dates for candidate declaration, campaign, and election periods for all open and/or vacant seats on the Senate, and

<u>Whereas</u>, there shall be a total of 39 Student Senate representative seats up for election, of which 11 represent students at-large, 12 represent off-campus students, 8 represent on-campus students, and 1 each represent students of the 8 academic colleges, and

<u>Whereas</u>, the office of Student Senate President and Vice President shall also be up for election, and

Whereas, it is custom for the Senate to do so, now therefore be it,

<u>Resolved</u>, that the University of Rhode Island Student Senate declares the following dates in accordance with the 2024 spring semester elections:

- Declaration period ends at 4 pm on Wednesday, February 28
- Eligibility confirmation Thursday, February 29
- Campaign period though Friday, March 8
- Election dates Monday, March 4 through Friday, March 8

Resolved, that the Senate urges all students to participate in the upcoming electoral process by both running for open seats and voting in the election.
