#### F. PUBLIC FORUM

Report of the President

Has been asked to find six to eight students to participate in an advisory group for the Department of Housing and Residential Life.

Vice President Reynolds Introducing Assistant Vice President for Housing and Residential Life Tom Cooley.

Vice President Reynolds

Provided statistics on newly admitted students.

Informs the Senate that the University will be implementing more programs to ensure a welcoming environment for incoming students.

Reminded the Student Senate that QuadFest will be held on Thursday, October fifth, the State of the University will be held on Tuesday, October tenth, and that Alumni weekend will take place between Friday, October thirteenth and Sunday, October fifteenth.

# Assistant Vice President Cooley

Confirms that he is looking for a group of students to form a housing advisory committee.

Emphasizes the need for transparent communication between his department and the student body.

#### G. REPORTS OF STANDING COMMITTEES

# Student Organization Committee

Chair Johnson informs that he will have bills from his committee on floor next week

Reminds the Senate that he is conducting the Presidents' Meeting for student organizations on Monday, October 2nd.

## Academic Affairs Committee

Chair Peckham reminds the Senate that there will be bill writing workshops on Monday, October second between 4:30-5:30 and also on Friday, October 6th between 3PM and 4PM.

## - External Affairs Committee

Chair Hoover informs the Senate that Ellen has responded positively to the idea of starting an off-campus newsletter to help inform students of disciplinary legal action that has been taken against students who rent off campus to remind students to stay responsible.

## Cultural Affairs Committee

Senator Johnson (committee member) informs the Senate that nearly all members of the Cultural Affairs Committee have started working on their own events and initiatives.

#### Campus Affairs Committee

Chair Buono informs the Senate that the Blue Light Walk will be happening in October. She explains what the Blue Light Walk is and how it helps keep the student body safe.

Senator Johnson asks if we know whether or not lights that are reported have been fixed.

Speaker Chadronet reminds the Senate that he used to be the chair of the Campus Affairs Committee. If lights have consistently recorded as non-functional remain non-functional, he will personally take legislative action ensuring that all lights are fixed within a short timeframe.

Senator Mayers requests that if legislative action was taken, it may also include making sure that fire alarms are audible in residence halls.

Speaker Chadronet informs Senator Mayers that residence hall fire alarms are likely managed by another department and are unrelated to the Blue Light system, making them irrelevant to such legislative action. He informs the General Assembly that the conversation is off topic and that if this topic is to be further discussed, it should be done in committee.

## **Elections Committee**
