3. DISCUSSION ITEM

a. Joint Alternate Retirement Plan Committee Update

Assistant Vice President (AVP) Anne Marie Coleman briefed the Board on the Joint Alternate Retirement Plan Committee's (JARPC) recent activity. The JARPC is responsible for the management of the 403(b) retirement plan offered to certain employees at URI, CCRI, RIC and the Office of the Postsecondary Commissioner. AVP Coleman noted that the JARPC is moving swiftly to implement the single record keeper for the 403(b) retirement system, having already approved the use of employer-controlled annuity contracts, the investment policy, the mapping strategy, the fee methodology, and the share class policy. The JARPC is now working with its consultant CAPTRUST and TIAA, with plans to move into the final stages of implementation in early 2023. Current providers have been notified that no further contributions will be made. AVP Coleman confirmed that there have been no issues; everything is running smoothly.

4. ACTION ITEMS

a. Review of the 2022-2025 tentative collective bargaining agreement between the University of Rhode Island Board of Trustees and the Maritime Professional Association, AFSCME, Council 94, Local 2877A, and recommendation for ratification to the URI Board of Trustees.

AVP Coleman noted that this three-year contract includes a 2.5% salary increase for the Maritime Professional Association.

Chair Cook called for a motion that the Executive Committee recommend that the Board of Trustees ratify the 2022-2025 tentative collective bargaining agreement between the University of Rhode Island Board of Trustees and the Maritime Professional Association AFSCME, Council 94, Local 2877A.
