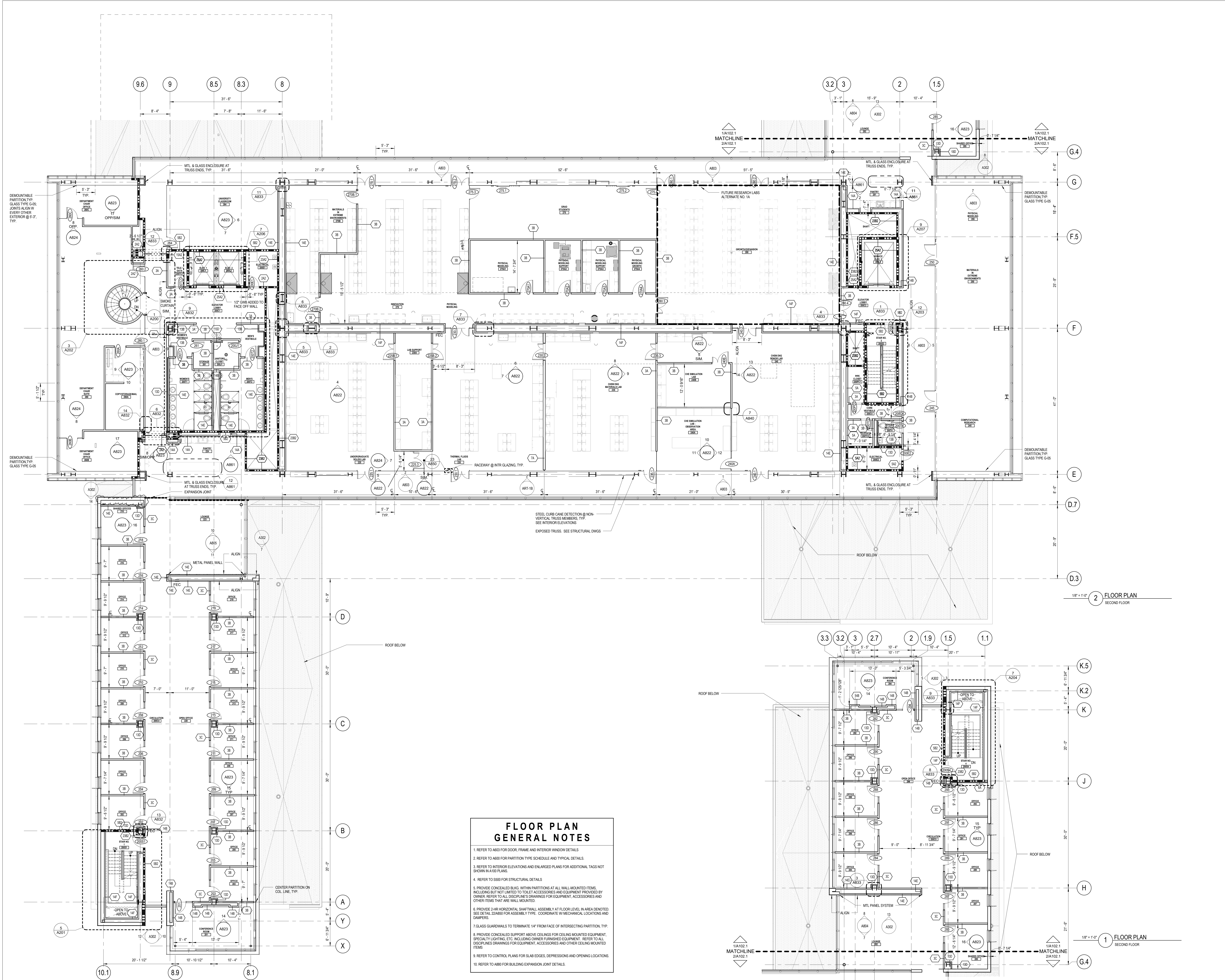

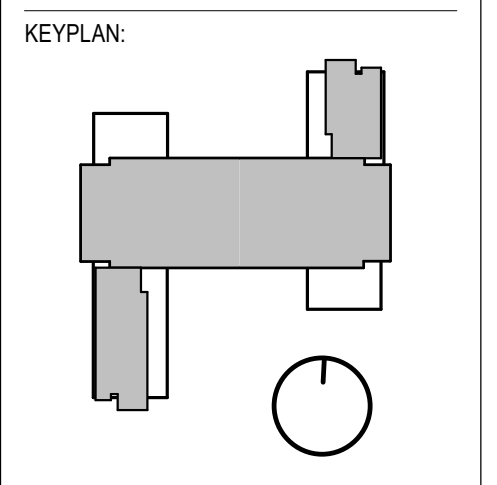

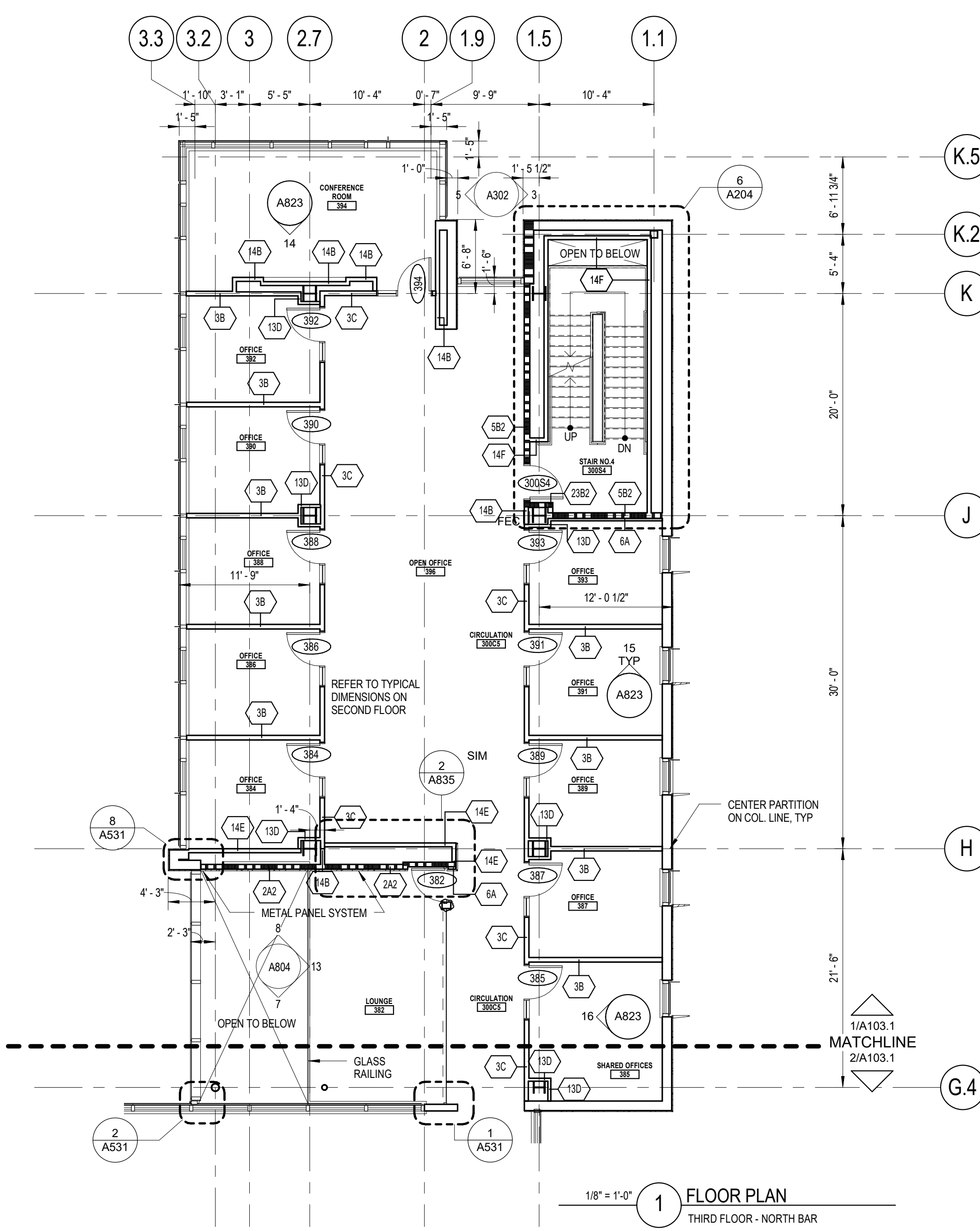
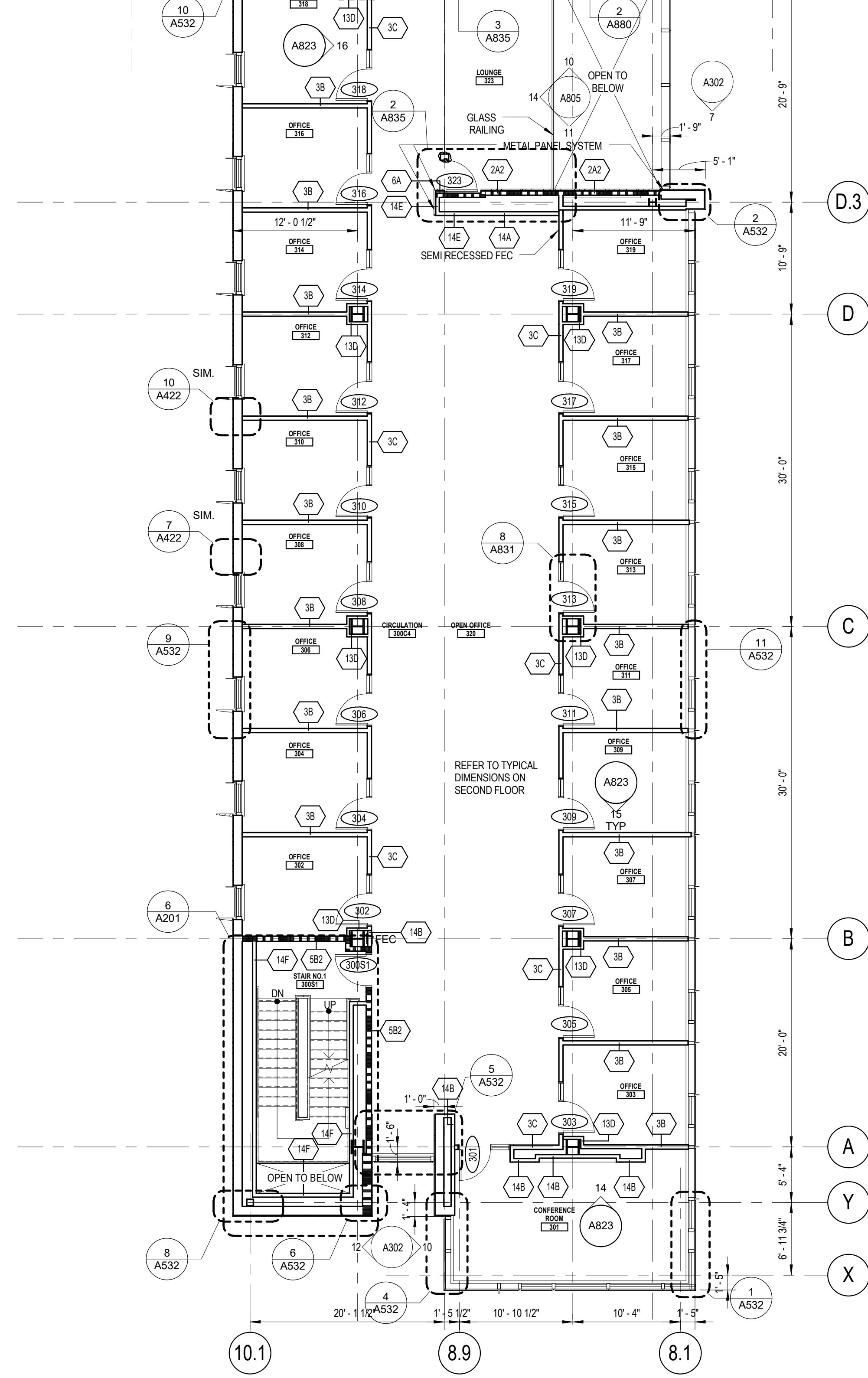
SECOND FLOOR PLAN

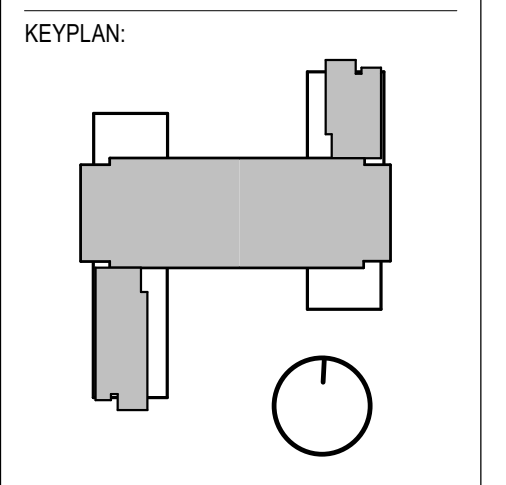

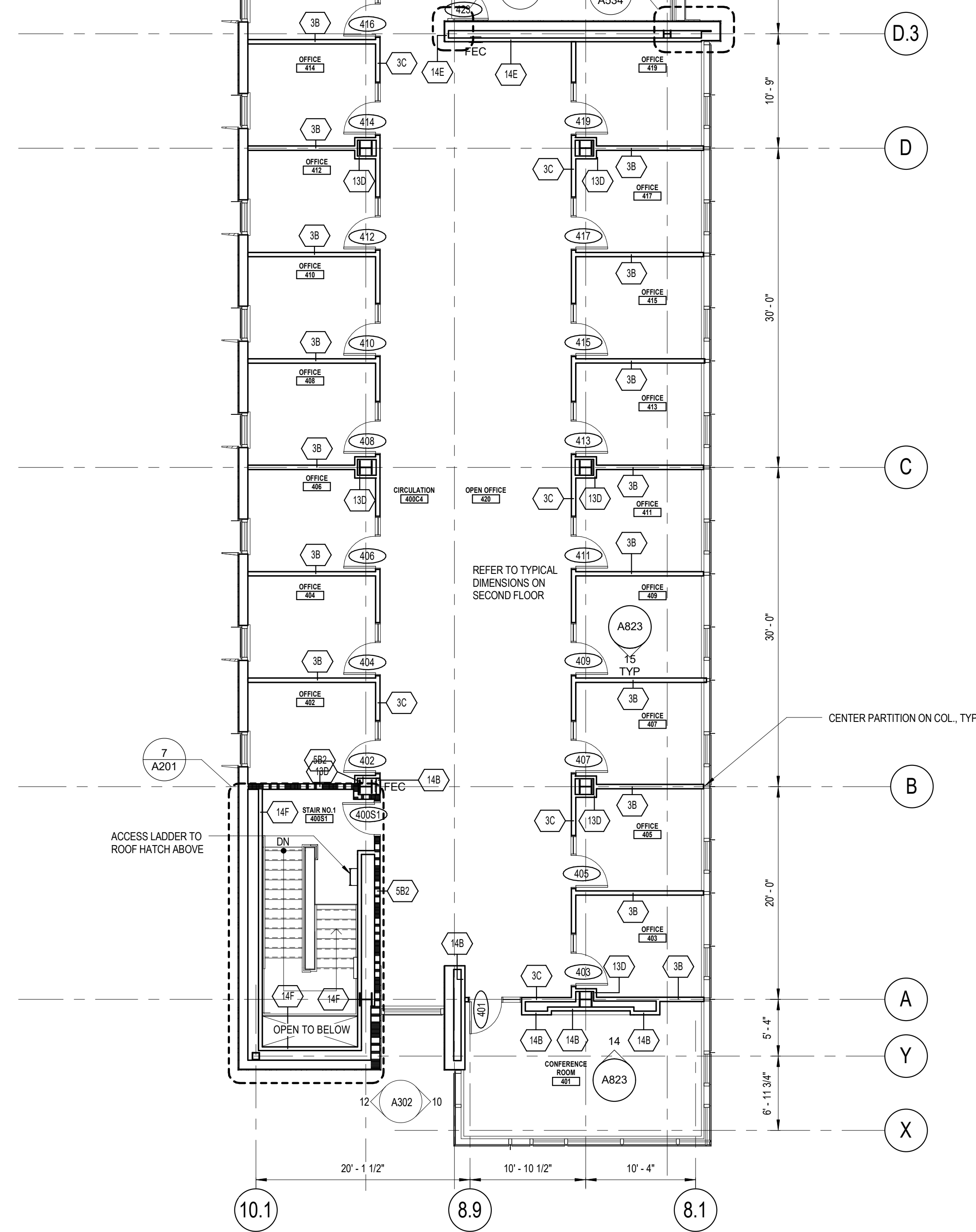

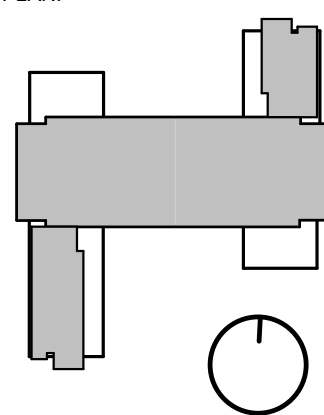

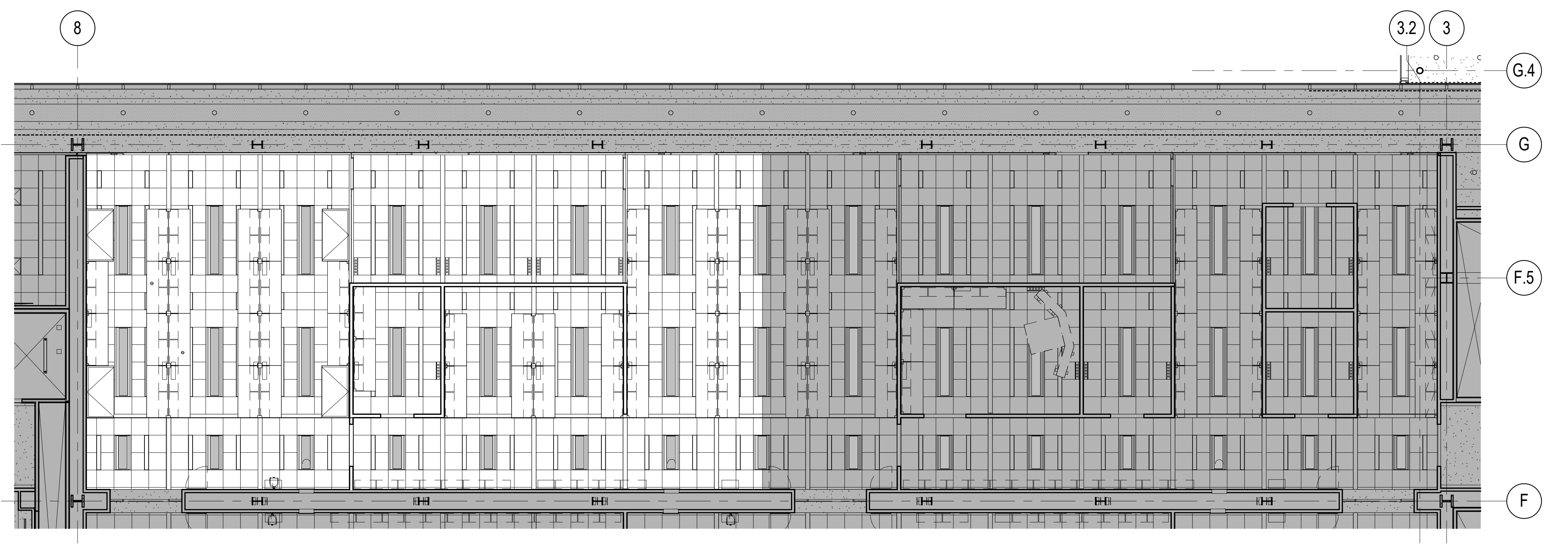

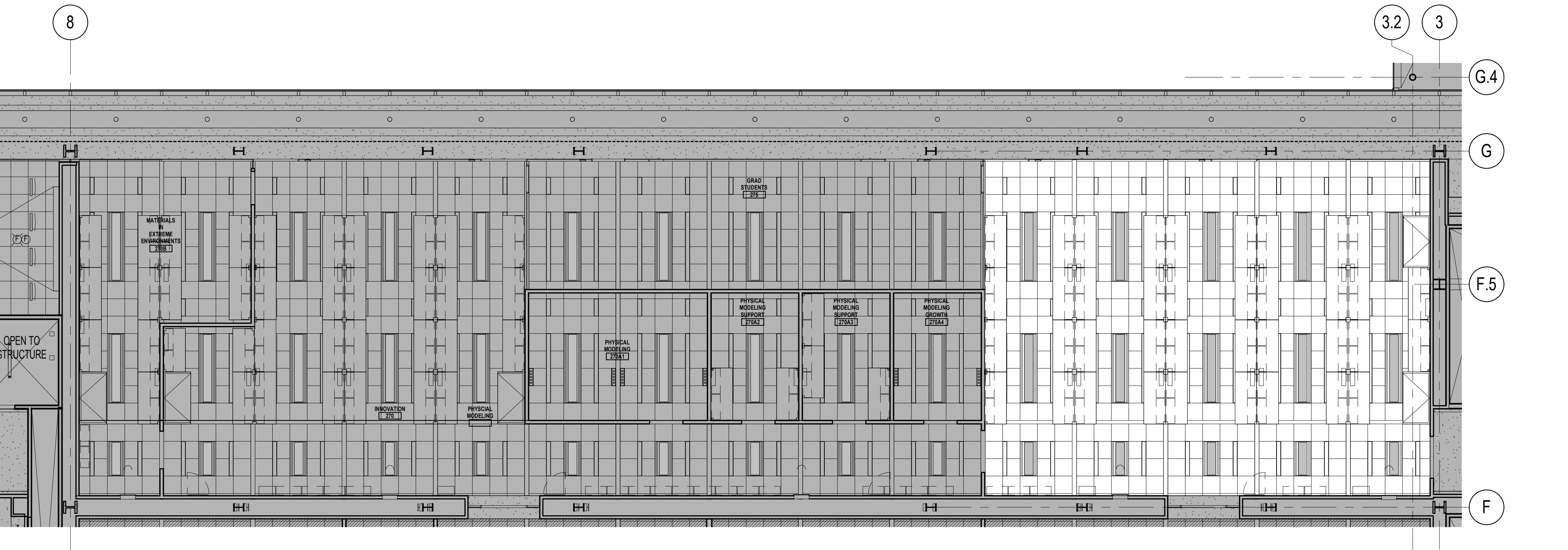

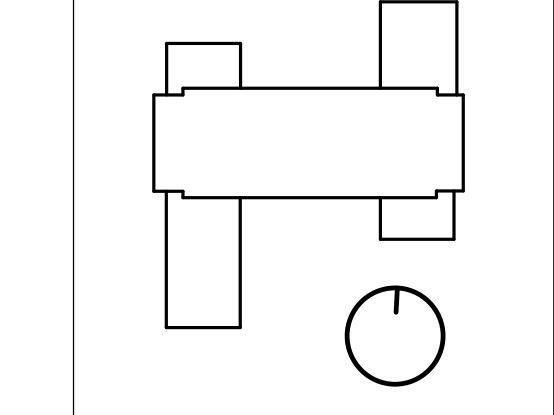
