DRAFT MINUTES

CELS Faculty and Professional Staff Meeting - April 27, 2021

- 1. The meeting was called to order at 10:45 a.m. on Tuesday, April 27, 2021 via Webex web meeting platform, with Dean Kirby presiding. Approximately 132 members of the CELS community were in attendance.
- 2. The Minutes from the September 2, 2020 CELS Faculty and Professional Staff Meeting were presented for approval and were approved without objection.

3. Announcements:

- a. Dean Kirby stated that he was proud of all faculty & staff accomplishments over the 2020-21 academic year of the Covid-19 pandemic. He has been working with the pre-tenure faculty to assure they are on track given the difficulties of the times. He urged all to not be too hard on themselves and maintain good spirits.
- b. June 1 is the 'reopening' target for Rhode Island per Governor McKee, however URI's reduced building and room capacities remain unchanged for the time being. CELS staff return to campus will be phased in given room capacities, and all are urged to be considerate and 'give people space.'
- c. Dean Kirby gave the floor to the *ad hoc* committees selecting the CELS Annual Excellence Awardees. The 2021 CELS Awardees were: Prof. Jannelle Couret, CELS Teacher of the Year; Prof. Soni Pradhanang, CELS Researcher of the Year; Vanessa Venturini, CELS Extension Professional of the Year; and Aura Grandidge, CELS Staff Member of the Year.

4. Elections:

- a. Faculty Secretary Rice thanked outgoing URI Senators Burroughs, Chandlee & Ruemmele, and welcomed in newly-elected Senators Emi Uchida, Brian Maynard and Lenore Martin who were recently elected to serve from 2021 to 2024.
- b. Faculty Secretary Rice presented the slate of candidates for election for service on CELS Committees from 2021 to 2024 and opened up the floor for further nominations. There were no new nominees, and nominations were closed. The slate of unopposed nominees was approved by unanimous voice vote with no abstentions.

- b. *Research Committee:* Committee Chair Niall Howlett provided a brief report of the Research Committee. Highlights are presented in Appendix 2. The primary concern of the committee over the semester has been in gathering greater support for proposal and post-award grant management by researchers.
- c. Cooperative Extension and Outreach Committee: Committee Chair Kate Venturini provided the report of the Cooperative Extension and Outreach Committee. Highlights included program pivots to support COVID-19 education efforts. See Appendix 3.
- d. Space Committee: Committee Chair Prof. Dawn Cardace provided a brief report on the activities of the committee. The committee webpage (https://web.uri.edu/celsgov/space-committee/) is updated with running minutes for all Committee meetings. A new Google Form version of CELS Space Request Form is on-line (https://forms.gle/1awg5uch5u5npVaz5) and the committee is monitoring it to make small improvements. A March 2020 survey allowed 'point persons' to be selected for all CELS shared spaces, and the committee looks forward to working together as research productivity recovers from COVID stresses.
- e. *Commencement Committee:* Committee Member Prof. Jodi Camberg provided a report on the activities of the Commencement Committee. Report is presented in Appendix 4.
- f. *Bylaws and Review Committee:* Committee Chair Katherine Petersson brought forth a seconded motion from the committee to amend the CELS Bylaws to readmit the Landscape Architecture Department back into CELS and return their degree programs to the college. - g. *Diversity Committee:* Prof. Amelia Moore provided a report of the activities of Diversity Committee (slides of her presentation are in Appendix 6). The committee was very active during the academic year in response to widespread concern for Justice, Equity, Diversity and Inclusion (JEDI) issues across Campus.

There was no old business.




- Dean Kirby announced that two faculty members were promoted to Associate Professor with Tenure:







RESEARCH: In the past 5 years, what efforts have you made to incorporate social justice, equity, diversity, and inclusion goals/strategies in your research? 9 responses

Respondents mentioned a variety of things from working directly with Indigenous tribes to incorporate traditional ecological knowledge into research protocols (one person) to designing one study that examined the factors, including field research experience, that affect BIPOC recruitment in geoscience (one person). In terms of ongoing and consistent research, one respondent said that they incorporate equity in some of their work on participatory processes, and one person said that all of their current research is oriented around JEDI, involves collaboration with underrepresented communities, or involves work with other scholars of color. One person mentioned that they advocate for

Attachment 2

Faculty Senate Report



The Faculty Senate's success in serving the Institution in shared governance and shared responsibility between Faculty, and the URI President and administration is predicated upon communication between Senators and the faculty they represent. To aid that communication, the Faculty Senate Executive Committee (FSEC) will highlight several "take-aways" from each Senate meeting for Senators to relay to their Colleges and Departments. Senators should also make note of items of particular interest to the faculty they represent and encourage and invite non-Senate faculty to share their concerns, questions, and comments for dissemination to Standing, Joint Committees, or FSEC for consideration. These "take-aways" are not meant to replace the necessity of consulting approved minutes at a later date for more complete information.

Senate November 2021 Meeting "Take-aways"

- Steering Committee for Strategic Planning. President Parlange announced plans for the formation of a Steering Committee for Strategic Planning for the next University-wide 5-year plan ending 2027. With the President as Chair, and Faculty Senate President as Vice Chair, the Steering Committee will include members of the Leadership Council, Academic Deans, a Faculty Senate Executive Committee Member, faculty at large, staff, and undergraduate and graduate student representatives.
- Admission Requirements. Associate Vice Provost for Enrollment Management Dean Libutti gave an encouraging report regarding enrollment. A question arose about the continuation of waiving the admission requirement of SAT and other standardized test scores after this academic year. Dean Libutti expressed appreciation for the Senate's role in supporting a test period of two academic years, after which the policy would be revisited.
- Curriculum Management System (CMS): Go Live. December 15th will be the Curriculum Management system "go live" date. Faculty will access the Kuali CMS application through the Office 365 page using their single sign-on credentials. All new proposals should use the CMS starting on that date; all PDF proposal forms will be removed from the Faculty Senate website. Information and tutorial videos will be made available to faculty. Course proposals (new and changes) and program pre-proposals should be submitted to the Senate using the platform by December 31st; Program proposals will have additional time to transition to CMS with a target date of January 21, 2022. Transitions to using new technology can be challenging; Use uri curriculum@uri.edu for questions about curriculum.
- General Education (GE) Assessment Participation. General Education Director DiCiccio highlighted the spring 2021 GE assessment data for outcomes B2, Communicate Effectively, and B4, Information Literacy. With limited faculty participation (30% and 36% participation respectively), plans to invite faculty earlier, work with colleges/departments to better support and encourage participation, and offer more time to assist faculty with assignment alignment were recommended. The full report to FSEC, GEC and GE Office will be made December 2021.
- University Manual (UM) Editorial Changes. The Senate approved UM changes to address editorial changes to bylaws, making all UM sections follow the same process. If a Senator objects to an item on the informational report, a motion and vote will follow, and if deemed a substantive change, the standard process will prevail.
