# Minutes of the March 22, 2021 Meeting of the CELS Executive Council

**Call to Order:** A meeting of the College of the Environment and Life Sciences Executive Council was held at 1:00pm via Webex Teleconference due to in-person meeting restrictions resulting from the COVID-19 pandemic. Members present were Department Chairs Chandlee, Dalton, Mitkowski, Paton, Petersson, Roberts, Savage and Uchida; Associate Deans Sartini, Sheely and Wilga; *ex-officio* members Palmer, Silvia and Wilson; and Faculty Secretary Rice. Dean Kirby presided.

**Approval of the Minutes:** A motion was made by Paton and seconded by Dalton to approve the March 8, 2020 Minutes of the Executive Council. The minutes were approved unanimously.

# **Announcements:**

### Dean Kirby

- 1. The major topic of the Council of Deans was that of 'burnout' among faculty, staff & students attendant to the COVID-19 pandemic and attendant protocols. All are urged to engage in self-care as appropriate.
- 2. In response to a query by Chair Roberts, discussion about the rollout of the 'Info-Ed' grant management platform ensued. There was discussion of greater clerical help within CELS to manage the workload presented by the new system.
- 3. The Office of Community, Equity and Diversity is conducting its annual Campus Climate Survey. All are urged to participate here: https://web.uri.edu/climate-survey/
- 4. The role of University College is under review, with Dean Jayne Richmond expected to be retiring at the end of June 2021.

# Associate Dean Sartini

- There was a discussion led by Associate Dean Sartini on the topic of Blended Courses. The
  original intent of blended courses was to assist in making classroom space available fore more
  courses. As a result, there is no specific requirement that the on-line portion be asynchronous.
  However, it is advisable that if there are courses to be listed as blended, it would be
  advantageous to most students that it be asynchronous (or recorded with video posted) to
  accommodate student schedules. There may be unusual instances in which some students, such
  as some on military scholarships that may have rarer requirements for attending regularly
  scheduled classes.

# Associate Dean Sheely

1. Associate Dean Sheely announced that the Landscape Architecture Department was authorized by the Faculty Senate to rejoin CELS. The move becomes effective July 1, 2021.
