### 3. REPORT OF THE CHIEF ACADEMIC OFFICER

Interim Provost and Vice President for Academic Affairs, Dr. Laura Beauvais, reported that she will continue as interim provost until the end of the calendar year. She then provided an update on the searches to fill several significant positions at URI.

- Candidates for the position of director of the Ryan Center for Neuroscience will be coming to campus later in June.
- The search for a new dean for the College of Business has been started, as Dean Ebrahimpour is stepping down, with Dr. Shaw Chen serving as interim dean.
- The search for a new dean of the University College of Academic Success, chaired by Dr. Danielle Dennis, is ongoing.
- Dr. Anne Veeger is chairing the search for a new Honors Program director.
- Finally, the dean of the College of Pharmacy, E. Paul Larrat, has notified us that he will be stepping down next year; and we are very appreciative of the long notice he is providing. A search will be upcoming.

Interim Provost Beauvais stated that the deans will have a retreat in August to discuss the ongoing new strategic planning initiatives, as well as working on enhancing URI's culture of scholarship. A subcommittee has identified areas that we will need to work on in more detail, including available academic space for scholarship and creative works, a

cost-effective model for faculty workload, and improvement of the interface between colleges. And finally, we will work with the deans on the goal of bringing the university community back together after the separations caused by COVID. General discussion followed.

#### 4. **REPORT OF THE CHIEF RESEARCH OFFICER**

Dr. Peter Snyder reported that after an excellent internal search, Dr. Elin Torell has been appointed as the new director of the Coastal Institute, following in the footsteps of Dr. Judith Swift, as she retires. Dr. Torell has decades of experience as a scientist, researcher, and administrator, with a focus on global warming and coastal justice.

URI was recently notified that one of the pending American Rescue Plan Act (ARPA) appropriations from the State of Rhode Island is \$70M over the next three years to grow the Blue Economy and the Build Back Better Regional Challenge (BBBRC). URI Research Foundation must provide \$35M from a successful BBBRC grant in order to receive access to the \$70M; URI will know by September if this will actually happen. It would be a transformative program going forward.

Dr. Snyder stated that at the last meeting we looked at the budget challenges in the Research Division, and he provided two documents from Hanover Associates that make up two thirds of their external audit of the Office of Sponsored Projects. There is an additional audit that he has not yet provided because it contains sensitive information, but by the next Academic Affairs and Research Committee meeting, he will present a forward plan to share for discussion and debate. Brief discussion followed.

#### 5. DISCUSSION ITEMS

## a. Review enrollment management activities, outcomes, and initial enrollment projections for 2022-23 academic year

Dr. Dean Libutti provided an enrollment update. He said that we are experiencing another record year for first-year applications, with an increase across most of the colleges. So far, gross deposits are looking good, as are out-of-state enrollments. (Enclosure 5.a.)

# b. 2022 Legislative Report, pursuant to R.I.G.L. § 16-32-2.1, Diversity efforts and progress related to student, staff and faculty recruitment and retention at URI. Enclosure 5.b.

Dr. Sean Rogers reported to the committee that the 2022 Annual Legislative Report has been compiled and submitted by the Office of Community, Equity and Diversity on the topics of recruitment and retention of diverse faculty and students. He is working across the University to build their tools to work on diversity and inclusion.
