#### **OFFICIAL MINUTES**

Committee Chair Christine Heenan welcomed everyone and thanked guests for attending the June 17, 2022, meeting of the University Advancement and External Affairs Committee of the University of Rhode Island Board of Trustees.

At 2:01 p.m. Chair Heenan took a roll call and acknowledged that a quorum of members was present and called the meeting to order.

## 3. DISCUSSION ITEMS

#### a. Update – Legislative and Government Relations Enclosure 3.a.

Mr. Carlos Lopez Estrada and Ms. Lauren Burgess, directors of Legislative and Government Relations, reviewed a presentation titled, <u>"The University of Rhode Island Advancement and External Affairs Subcommittee,"</u> which outlined the state budget and a review of the legislative team's progress and successful accomplishments related to the Blue Economy and the Narragansett Bay Campus (NBC).

Mr. Lopez Estrada provided updates that included securing a \$100M bond for the replacement of the NBC Horn building; \$37M in the Rhode Island Capital Plan (RICAP) Fund (also for the NBC); with total dollars received from RICAP, for the year, at \$140M for repair and maintenance of facilities.

Chair Heenan invited Ms. Lauren Burgess to also provide the Committee with updates and an overview of the new approach towards federal relations that Ms. Burgess has initiated since she arrived at the University.

Ms. Burgess provided an overview of the proactive and strategic long-term approach they are stewarding, with ongoing efforts to advance the University's agenda by engaging the University's Congressional delegation and champions of the University to secure millions of dollars in congressionally-directed spending for new projects earmarked for the University. Opportunity for success with the Economic Development Administration (EDA) Build Back Better Regional Challenge grant for \$7M of matching funds was noted, and if successful, would support the Blue Technology Innovation Center.

Ms. Burgess explained that the legislative team has started the process for the upcoming fiscal year 2023, with a focus on a much more synergistic strategy to move the University's agenda forward.

Chair Heenan thanked both Mr. Lopez Estrada and Ms. Burgess and asked Committee members if they had any questions.

Mr. McNally stated that while the team did a great job securing funding, efforts started too late to impact greater funding and that the State also needs to provide greater funding as well.

Chair Heenan responded by asking Mr. McNally if his perspective was relative to the General Assembly's priorities over the past year as opposed to a multi-year process of being a central priority that is viewed as a critical engine of economic development and state advancement. Mr. McNally concurred with Chair Heenan's assessment of his comment.

Chair Heenan stated that the topic would be great to discuss at the Board's retreat. She proceeded to open the floor to Committee members for comments and discussion in which several members provided comments.

#### b. Update - Big Ideas. Bold Plans. The Campaign for the University of Rhode Island; RhodyNow Enclosure 3.b.

Jeffrey Cabral, Vice President, URI Foundation & Alumni Engagement, provided an overview of a presentation titled, <u>"URI Foundation & Alumni Engagement"</u> and reported on the progress of the current Campaign which has raised gifts totaling \$234M towards the \$300M goal as of June 16, 2022, with anticipation of reaching \$240M by the fall. Several gifts are pending, including \$3M in anonymous gifts towards the NBC bond, \$5M for the Economic Development Administration Blue Economy, as well as other gifts.

Vice President Cabral also provided an overview of Campaign commitments by purpose (endowed, RhodyNow, and operating gifts). There are several \$1M donor requests in the pipeline. He informed the Committee that a recession and current stock market conditions may have some psychological effect where donors could hold off when considering making gifts. Vice President Cabral informed the Committee that institutions across the country are also expressing the same concern and that the team is doing a great deal to offset any hesitancy. He is optimistic that they will make the \$300M Campaign goal.

Vice President Cabral stated that they had a strong annual fund performance this year, surpassing the fiscal year goal of \$2.5M and are nearing 6,000 RhodyNow donors while referencing a gain of

over 1,000 new donors from last October's Annual Day of Giving. He also referenced a recent nationwide survey that was conducted on annual fund results at colleges and universities in which only 28% of respondents stated that they have seen an increase in donors and dollars for this fiscal year. We are pleased that URI may end in the top 28 percent. Vice President Cabral thanked the Committee and guests for their support and gifts.

Committee member Nicolato asked Vice President Cabral to explain the difference between the donor numbers from the fiscal year 2017 to the fiscal year 2022. He stated that the difference is the implementation of "best practices" starting in fiscal year 2020, where prior to 2020 every gift was counted regardless of the amount. This inflated the numbers drastically. Fiscal years 2021 and 2022 utilized "best practices" to count gifts of \$55 and above to provide a true assessment.

Ms. Nicolato also asked what the demographic makeup is of the RhodyNow donors. Vice President Cabral stated that it varies across all demographics of our population. Next year they will be looking at how donors want to be engaged and will be increasing their text-to-give and social media platforms and outreach to younger donors, in combination with the standard practices of direct mail solicitations. Vice President Cabral also mentioned the new online giving platform that was just launched. They are also close to launching a brand-new webpage for the Foundation and Alumni Engagement. Chair Heenan thanked Vice President Cabral and moved to Discussion item 3.c.

#### c. Search Update – Vice President, Communications & Marketing

Chair Heenan announced the addition of a new Vice President for Communications and Marketing, Matthew McDonald, who currently serves as the associate vice president for Communications at the University of Miami. Chair Heenan provided an overview of Mr. McDonald's expertise and her knowledge of his career from her time in Boston when Mr. McDonald was creating riveting competitiveness and global attention from his tenure at Northeastern University.

Chair Heenan also took the time to thank Interim Executive Director for External Relations and Communications, Ms. Linda Acciardo, for her role in the search committee that brought Mr. McDonald to the University. Chair Heenan also thanked Ms. Acciardo for her years of service at the University overseeing every aspect of communications. President Parlange concurred with Chair Heenan and thanked Ms. Acciardo for her service and commitment to the University, for serving on the search committee for the new vice president, and for postponing her retirement.

Chair Heenan thanked everyone and called for a motion to adjourn the June 17, 2022 meeting.
