# 4. DISCUSSION ITEM

a. Update Report: Joint Alternate Retirement Plan Committee

Assistant Vice President Anne Marie Coleman briefed the Board on the Joint Alternate Retirement Plan Committee's (JARPC) recent activity. The JARPC is responsible for the management of the 403(b) retirement plan offered to certain employees at URI, CCRI, RIC and the Office of the Postsecondary Commissioner. A contract has been awarded to TIAA to serve as the single record keeper for the retirement plan. All participants in the 403(b) plan have been notified of TIAA's record keeper status. The JARPC held three meetings over the past month. Committee members received extensive fiduciary training. Further meetings will be held in July to determine investment menu design, the investment policy, the mapping strategy plan design and the fee methodology.

Assistant Vice President Coleman will provide an update report at the September Executive Committee meeting.
