Chair Cook stated that the Finance and Facilities Committee met on August 2, 2022 to discuss changes the University would like to make to the Capital Improvement Plan that the Board approved at its June 24, 2022 meeting. She called upon Finance Committee Chair Michael Fascitelli to report on the Committee's review of the proposed changes.

4. REPORT OF THE FINANCE AND FACILITIES COMMITTEE CHAIR

a. Update – August 2, 2022 Committee Meeting

b. ACTION ITEM: Approval of changes in the University of Rhode Island Capital Improvement Plan FY2024-2028. Enclosure 4.b.(i) Enclosure 4.b.(ii)

Finance Committee Chair Michael Fascitelli reported that the Committee met on August 2, 2022 to review two proposed changes to the approved URI Capital Improvement Plan FY2024-2028. He called upon Vice President Abigail Rider to explain the changes.

Vice President Rider reported that the University would like to change the requested funding source for the following facilities improvements from an FY24 referendum bond to Rhode Island Capital Plan (RICAP) funding: Athletics Complex Improvement, including the Meade Stadium east grandstands, the Slade Track & Field, the Beck Baseball Field, the softball field, the soccer field and Tootell pool repairs, at an estimated cost of \$82,300,000.

The second proposed change is an addition to the approved Capital Improvement Plan to build a water treatment facility at URI. The addition is in response to legislation passed during this year's session of the General Assembly requiring all water systems in the state to achieve a level of 20 parts per trillion or less of so-called "forever chemicals" (PFAS – per- and polyfluoroalkyl substances) by July 1, 2023. Vice President Rider reported that current levels of PFAS within the University's water system are not significantly higher, but may not meet the new standard. In order to assure that we will be able to meet the standard, the University must construct a water treatment facility. The preliminary planning cost estimate for a new water treatment facility is \$20 million. She noted that the University is exploring funding options with the congressional delegation and the Rhode Island Infrastructure Bank. Director Lopez Estrada added that URI is also working with Commerce Rhode Island to access federal funding for this project.

Committee Chair Fascitelli reported that the Committee recommended unanimously that the full Board approve the changes to the Capital Improvement Plan.
