3. DISCUSSION ITEM

a. Board of Trustees Remote Meeting Participation Enclosure 3.a.

Chair Nicolato introduced this discussion item and asked General Counsel Alyssa Boss to walk the Committee through the draft policy document.

General Counsel Boss stated that recent legislative changes to the Open Meetings Act (OMA) allow the University of Rhode Island Board of Trustees to meet remotely provided a quorum is in person. The Board of Trustees must create rules; this policy is intended to comply with the provisions of the OMA.

Committee members reviewed the draft Board of Trustees Remote Meeting Participation policy statement and the itemized provisions of the policy. Committee members expressed thoughtful comments on some of the itemized provisions. Following discussion, the general counsel was directed to strike Items 4 and 5 from the draft document and modify language in Items 7 and 8.

The revised draft policy entitled "Board of Trustees Remote Meeting Participation" will be considered at the September 23, 2021 Governance Committee meeting, with planned action to recommend for approval to the URI Board of Trustees.

Chair Nicolato stated that a lot of legislation tied to the URI Board of Trustees relates to its setup, and not to its management. She noted that policies governing Board management will be identified and considered by the Committee at future meetings.
