

UNEMPLOYMENT TUITION WAIVER INSTRUCTIONS

Accelerated Online Programs FALL 2022

Individuals receiving unemployment benefits from the State of Rhode Island may be eligible for a waiver of tuition and the registration fee for courses taken at URI.

Students must submit the following:

1. DET Certification of UI Eligibility Form (DET-467). The form must be dated as follows:
 - a. After July 7, 2022 and before September 6, 2022 for Session 1 courses.
 - b. After September 1, 2022 and before November 1, 2022 for Session 2 courses.
 - c. Students adding a Session 2 course, after initially enrolling for a Session 1 course, will be required to submit a second DET-467 form with the appropriate dates recorded.
2. RI Public Higher Education Unemployed Means Test
3. Signed Copy of 2021 Federal Form 1040
4. Copy of all 2021 W2 Forms for the Unemployed
5. Copy of RI Driver's License or RI State ID
6. Payment of required fees not covered by the waiver

NOTE: Tuition waiver requests will not be processed if forms are incomplete, documentation is missing, or if payment for required fees is not presented. Waivers cannot be used for non-credit courses, program fees, or audit fees.

IMPORTANT NOTICE:

Waiver recipients enrolled in a degree program (matriculated students) are required to apply for Financial Aid by filing the 2022-2023 Free Application for Federal Student Aid (FAFSA). Please apply online at www.fafsa.ed.gov. (To complete Step 6 of the FAFSA form, students should enter 003414, University of Rhode Island, Kingston, RI.) Any scholarship or grant aid awarded will be applied toward your tuition in lieu of your waiver, and the amount of your waiver will be reduced accordingly. Waiver applications will be returned or denied if the FAFSA is not completed.

If you are considered a dependent student for financial aid purposes, you are not eligible for an unemployment waiver.
