Academic Standards and Calendar Committee Report #2014-15-1**

The Academic Standards and Calendar Committee met on 10 October 2014.

We discussed a proposal to revise the manual to correct an error introduced last year as well as the 2020-2021 calendar.

We propose the following manual change:

Current 8.53.30 (recent changes to the manual in red bold)

S/U Courses. Certain courses do not lend themselves to precise grading (e.g., research, seminar). For these courses, only a Satisfactory (S) or Unsatisfactory (U) shall be given to all students enrolled. To qualify as an S/U course, the course must be approved by the Faculty Senate after recommendation by the Curricular Affairs Committee and/or the Graduate Council. S/U courses shall be so labeled in the University Bulletin. An S/U course is not to be counted as a course taken under the Pass/Fail grading option. Courses numbered below 100 **or 500 and above** that are graded on an S/U basis shall not be included in the calculation of a student's quality point average or credits earned.

New proposed change

S/U Courses. Certain courses do not lend themselves to precise grading (e.g., research, seminar). For these courses, only a Satisfactory (S) or Unsatisfactory (U) shall be given to all students enrolled. To qualify as an S/U course, the course must be approved by the Faculty Senate after recommendation by the Curricular Affairs Committee and/or the Graduate Council. S/U courses shall be so labeled in the University Bulletin. An S/U course is not to be counted as a course taken under the Pass/Fail grading option. Courses numbered below 100 ~~or 500 and above~~ that are graded on an S/U basis shall not be included in the calculation of a student's quality point average or credits earned. **Courses numbered above 500 that are graded on an S/U basis shall not be included in the calculation of a student's quality point average.**

Rationale

A manual change this committee proposed, and which went through Faculty Senate approval last year contained what we now realize was an error. The changes, which were intended to reconcile a conflict between practice and policy and between the graduate manual and the university manual about S/U grades at

the graduate level, changed more than anyone intended. We inadvertently changed language in the university manual such that now classes at 500 and over don't count for credit, versus not counting for quality points in the GPA as intended. This is problematic for a variety of reasons, not least that most graduate programs include courses and/or thesis credits that are essential to the degree and credit count, but are graded as S/U. The proposed revision corrects that error recently introduced into the manual.
