### Intellectual Property Rights Assignment

#### Minimum Effort on Sponsored Projects Guidance (May 2022)

- https://web.uri.edu/research-admin/files/Minimum-Effort-Guideline-May-2022.pdf
- "The minimum amount of effort committed to a specific sponsored research activity may be no less than 1 percent of the Principal Investigator and other key personnel's university effort."
- Any portion of effort for which the sponsor does not pay is considered cost-share and must be approved by VPR
- Exclusions exist

#### Federal guidance on the topic:

- "most Federally-funded research programs should have some level of committed faculty (or senior researchers) effort, paid or unpaid by the Federal government. This effort can be provided at any time within the fiscal year (summer months, academic year, or both)."

#### Research Integrity Updates

#### Export Control Policy Reminders

- Defines U.S. Person status
  - Includes U.S. Citizens & Lawful Permanent Residents of the U.S.
- Defines Foreign Person status
  - Includes any person who is not a U.S. Person
    - Examples: H1B, J1, F1 visa holders
- Applies to all:
  - URI personnel/employees
  - students and postdocs
  - visiting scientists
  - other persons retained by or working for URI
    - Includes personnel at any URI center or institute
      - ➤ Examples: NIUVT, CYPHER, CRC
- Policy On Export Control Compliance (uri.edu)





#### Research Integrity Updates

- Policy on University Technology and Sponsored Non-Immigrant Aliens (URI policy number 5.102.1)
- Policy applies to all J-1, H-1B, F-1 (graduate and postdoctoral fellows) non-immigrant visa holders from countries listed as State Sponsors of Terrorism by the U.S. Department of State or from a countries known to engage in industrial espionage as defined by the National Counterintelligence and Security Center.
- This policy refers to and covers nonimmigrant visa holders who are sponsored by URI and accessing URI IT networks.
- The policy requires that devices used to access URI networks by sponsored individuals run approved operating systems, up-to-date antivirus software and endpoint security protection. This includes both University owned and any personal device which may connect to a University network and is used for University business or Universitysponsored research.
- Policy does NOT apply to traditional, full-time F-1 undergraduate students.

Summary-University personnel sponsoring non-immigrant aliens should be aware of the requirement to have both University issued and personally owned electronics cleared by URI IT security before allowing access to URI networks for business or sponsored research.
