

Bachelor of Music degree, Music Education major: (See Appendix A)

The changes proposed aim to make the degree in music education more equitable for all students who successfully pass an audition for acceptance into the music department.

College of Health Sciences:

Create a new Course Code - CHS (College of Health Sciences) (See Appendix B)

The proposed CHS prefix stands for the College of Health Sciences and will be used for interdisciplinary undergraduate and graduate courses offered by the college. Two interdisciplinary courses are being proposed as part of the new Ph.D. in Health Sciences (currently under review), which crosses 6 departments/programs (Communicative Disorders, Health Studies, Human Development and Family Studies, Kinesiology, Nutrition and Food Sciences, and Physical Therapy). The prefix will also be used for interdisciplinary, college-wide grand challenge courses that are currently under development. These courses will be topic-specific, rather than departmental specific, and will show different approaches to solving some of the most critical health issues of today. The CHS course prefix will be a signal to students that the course will approach these issues

from multiple viewpoints. For example, a course on healthy aging may include faculty from every CHS department/program to demonstrate a lifespan approach staying healthy across the lifespan.

The Director of the PhD in Health Sciences, who has not been identified, will have signature authority for all graduate level CHS courses. The chair of the CHS curriculum committee (currently Associate Dean Brian Quilliam) will have signature authority on all future forms.
