The Committee on Information Technologies, Infrastructure, Computing, Communications, and Networking contributes to the development and maintenance of the strategic plan in collaboration with Information Technology Services and reviews and makes policy recommendations regarding the implications on academic and research planning, standards, services, physical facilities, and allocation of resources on all matters pertaining to information technology, infrastructure, computing, communications, and networking. CITICCN has had an active year with five meetings so far during Academic Year 2015-2016, the first year of engagement for the committee. During Spring 2016 semester, the committee meets monthly. CITICCN had engaged in a number of topics (as documented in the minutes of the committee meetings posted on the FS website <http://web.uri.edu/facsen/committees/committee-on-information-technologies-infrastructure-computing-communications-and-networking/>) that include the following significant activities:

#### **1. Evaluation of IT Governance (ITgov) Committee Membership and Charge**

Last December, CITICCN reviewed the DRAFT documents issued by Provost DeHayes and VP Valentino on the membership and charge of a newly proposed presidential committee called IT Governance Steering Committee. CITICCN members noted that there were obvious deficiencies in the membership regarding representation of different IT components of the university. In particular, it was noted that GSO and the Providence Campus run somewhat independent IT operations but there are no representatives from either group on the ITgov committee. Additionally, it was noted that the proposed membership of the ITgov included individuals that only have partial knowledge of IT operations, plans, and projects. As a result of this evaluation, CITICCN issued a memorandum with recommendations to the Provost and VP for Finance to include representation from GSO and Providence campus on the committee and add the CIO, Garry Bozylinsky, as an ex-officio member to ITgov. #### **2. IT Strategic Planning**

CITICCN is now engaged with IT strategic planning in collaboration with ITgov. The IT strategic

planning is contracted to the BerryDunn consultants by URI. BerryDunn has issued an IT assessment report (see <http://web.uri.edu/itgov/>) which was released in February 2016. They are now engaged in setting up a number of strategic planning workshops to develop the strategic plan. CITICCN members have been nominated and encouraged to participate in workshop sessions. We hope that all faculty will engage in expressing their views on IT services, infrastructure, computing, networking, and communications at URI. The survey will be released in April.

#### **5. CIO Transition at URI**

Recent resignation of CIO Bozylinsky from URI has resulted in the appointment of an interim CIO, Mr. Richard Kubica, who has accepted this position on a temporary basis until a search can be conducted for a permanent CIO. It is expected that CITICCN will be engaged in the process for the search.
