# REPORT OF THE FACULTY SENATE LIBRARY COMMITTEE May 7, 2015

## **Meeting Dates**

The Faculty Senate Library Committee met twice during 2014/15: November 21 and February 18.

#### Activities

During 2014/15, the Committee continued to focus its attention on issues related to the University of Rhode Island Open-Access Policy (OAP). The Committee:

- Developed a proposal to amend the charge of the Committee to make the Faculty Senate Designate for the OAP a permanent, voting member of the Faculty Senate Library Committee (see below). The reason for this change is that since the OAP is now a significant component of the Committee's charge, it will be helpful to have the Designate present at meetings.
- Reviewed the library's process of identifying articles and requesting article manuscripts from faculty, and faculty response rate to these requests.
- Discussed publicity strategies for increasing faculty awareness of and compliance with the OAP.
- Discussed potential institutional efforts for gathering and disseminating information about faculty publications as well as enhancing faculty compliance with the OAP. Decided that in 2015/16, members of the Faculty Senate Library Committee will seek to bring these issues before the deans.
- In response to faculty concerns, agreed to update the content of monthly
  promotional emails: Instead of an email reporting on the top three mostdownloaded OAP articles in the previous month, one OAP article will be
  selected to highlight. It will be posted with its abstract but without download
  data.
- Noted the fact that in 2015/16 the Committee will need to produce a threeyear review of the OAP and discussed general strategies for creating such a report.

## Proposal to update the charge of the Faculty Senate Library Committee [requires Faculty Senate approval]

Current language with proposed changes highlighted in red:

4.50 The Library Committee. This committee shall act as liaison between the University Library and the faculty as a whole and advise the Library on matters of general faculty concern; consult with the Library faculty on long-range needs of the Library and the adequacy of budget provisions to meet those needs; serve in an advisory capacity to the Faculty Senate regarding the implementation and interpretation of the University of Rhode Island Open-Access Policy, resolving disputes concerning the interpretation and application of the policy, and recommending changes in the policy to the Faculty Senate; report annually to the Faculty Senate and propose Senate action relating to the University Library. The Faculty Senate Designate for the URI Open-Access Policy shall serve as a voting ex officio member of the Library Committee. The Dean of University Libraries shall serve as an ex officio non-voting member of the Library Committee.

## Final language as proposed:

4.50 The Library Committee. This committee shall act as liaison between the University Library and the faculty as a whole and advise the Library on matters of general faculty concern; consult with the Library faculty on long-range needs of the Library and the adequacy of budget provisions to meet those needs; serve in an advisory capacity to the Faculty Senate regarding the implementation and interpretation of the University of Rhode Island Open-Access Policy, resolving disputes concerning the interpretation and application of the policy, and recommending changes in the policy to the Faculty Senate; report annually to the Faculty Senate and propose Senate action relating to the University Library. The Faculty Senate Designate for the URI Open-Access Policy shall serve as a voting ex officio member of the Library Committee. The Dean of University Libraries shall serve as an ex officio non-voting member of the Library Committee.
